Jeffrey A. Mangan, Commissioner of Political Practices to Yes for Cascade County Jobs, Ballot Issue Committee No. NC-17-001	ORDER OF NONCOMPLIANCE

WHEREAS, the above named committee, Yes for Cascade County Jobs, is a Ballot Issue Committee organized on February 24, 2017 as evidenced by an examination of a Statement of Organization filed with the Commissioner of Political Practices; and

WHEREAS, the Robert Bulcher is listed as the duly appointed Treasurer for Yes for Cascade County Jobs as evidenced by an examination of a Statement of Organization filed with the Commissioner of Political Practices; and

WHEREAS, despite information provided to Yes for Cascade County Jobs relative to committee reporting obligations through Brett Doney, Great Falls Development Authority on September 1, 2017, and emails to the committee's reported email address prior to the October 3 and 26, 2017 campaign finance report filing deadlines. Yes for Cascade County Jobs, has failed to:

- File its required campaign finance report for the period of its first contribution or expenditure through September 28, 2017 due on October 3, 2017;
- File its required campaign finance report for the period of September 29 through October 21, 2017 due on October 26, 2017;
- Failed to report expenditures – a least two 11 x 8.5 inch double sided four-color flyers “Vote Yes Cascade County Economic Development Levy” have been mailed via USPS; Yes Cascade County Economic Development Levy yard signs are posted in Great Falls; and
- Update its C2 Statement of Organization with an apparent new Treasurer contact information (as Bruce Len Watkins, Treasurer is printed on the Vote Yes Cascade County Economic Development Levy flyer attribution).

A Copy of Yes for Cascade County Jobs C2 Statement of Organization is attached; Copies of “Vote Yes for Cascade County Jobs” flyers are attached.

IT IS FURTHER ORDERED, pursuant to 13-37-121, MCA, that Yes for Cascade County Jobs is and is declared to be in NONCOMPLIANCE with the provisions of sections 13-37-225, MCA, and ARM 44.11.302; and

IT IS FURTHER ORDERED, that a County Attorney or the Commissioner may, on failure by Yes for Cascade County Jobs to submit appropriate campaign finance reports within 5 days after receiving this Order of

Noncompliance, may initiate a civil action pursuant to sections 13-37-124 and 13-37-128, MCA; and

FURTHER, if Yes for Cascade County Jobs is aggrieved by the issuance of this Order of Noncompliance, it may seek judicial review in District Court pursuant to section 13-37-122, MCA.
