Dear Commissioner Mangan:

The Republican Governors Association (RGA) has been sending out tens of thousands of text messages opposing Mike Cooney, with out any disclaimers at all, in clear violation of MCA 13-25-225.

The phone numbers that these messages are sent from do not connect to a phone and the senders do not reply to questions of who is behind the election communication. The only reason we know the RGA is responsible is in Exhibit A they link to a website the RGA owns and operates that expressly advocates for the defeat of Mike Cooney for Governor. This is a common practice in political communications to link people a landing page which you own. The two additional texts (see exhibit B & C) do not even provide the voter with a clue of who paid for the communication, in clear violation of ARM 44.11.601.

As there is no way to correct this election material, I ask that you find the RGA out of compliance with Montana election law and subject the RGA to a civil penalty pursuant to MCA 13-37-128.




