WHEREAS, the above named candidate, Shane Vannatta, is an Independent candidate for election to District Judge, District 04 Dept. 05 in Missoula County, as evidenced by the January 9, 2020 filing with the Montana Secretary of State; and

WHEREAS, Shane Vannatta electronically filed a Statement of Candidate C-1 form on January 12, 2020 using the Candidate Electronic Reporting System (CERS) with the Commissioner of Political Practices; and

WHEREAS, despite public reporting calendars, COPP website and social media updates, instruction<sup>1</sup> and guidance provided to Candidate Vannatta by COPP staff, candidate Vannatta has failed to:

- File the required C-5 campaign financial report on or before March 20, 2020 for the period of March 9, 2020 to March 15, 2020;

- File the required C-5 campaign financial report on or before April 20, 2020 for the period of March 16, 2020 to April 15, 2020;


A Copy of the candidate's Statement of Candidate is attached.

IT IS FURTHER ORDERED, pursuant to §13-37-121, MCA, that Shane Vannatta is declared to be in NONCOMPLIANCE with the provisions of section § 13-37-225, MCA and ARM 44.11.302; and

IT IS FURTHER ORDERED that a County Attorney or the Commissioner may, on failure by Shane Vannatta to submit appropriate campaign finance reports within 5 days after receiving this Order of Noncompliance, may initiate a civil action pursuant to sections §13-37-124 and §13-37-128, MCA; and

FURTHER, if Shane Vannatta is aggrieved by the issuance of this Order of Noncompliance, he may seek judicial review in District Court pursuant to section §13-37-122, MCA.
