WHEREAS, the above named candidate, Andrew Schaefer, is a Libertarian candidate for election to Montana House District 67 in Gallatin County, as evidenced by the January 9, 2020 filing with the Montana Secretary of State; and

WHEREAS, Andrew Schaefer electronically filed a Statement of Candidate C-1 form on January 14, 2020 using the Candidate Electronic Reporting System (CERS) with the Commissioner of Political Practices; and

WHEREAS, despite public reporting calendars, COPP website and social media updates, instruction¹ and guidance provided to Candidate Schaefer by COPP staff, candidate Schaefer has failed to:

- File the required C-5 campaign financial report on or before March 20, 2020 for the period of March 9, 2020 to March 15, 2020;

- File the required C-5 campaign financial report on or before April 20, 2020 for the period of March 16, 2020 to April 15, 2020;


A Copy of the candidate's Statement of Candidate is attached.

IT IS FURTHER ORDERED, pursuant to §13-37-121, MCA, that Andrew Schaefer is declared to be in NONCOMPLIANCE with the provisions of section § 13-37-225, MCA and ARM 44.11.302; and

IT IS FURTHER ORDERED that a County Attorney or the Commissioner may, on failure by Andrew Schaefer to submit appropriate campaign finance reports within 5 days after receiving this Order of Noncompliance, may initiate a civil action pursuant to sections §13-37-124 and §13-37-128, MCA; and

FURTHER, if Andrew Schaefer is aggrieved by the issuance of this Order of Noncompliance, he may seek judicial review in District Court pursuant to section §13-37-122, MCA.
