ORDER OF NONCOMPLIANCE

To: Walter Joyce

No. COPP-2021-ONC-003

WHEREAS, the above named candidate, On June 16, 2021, Walter Joyce filed a Declaration of Nomination and Oath of Candidacy with the Meagher County elections department; and

WHEREAS, Walter Joyce filed a C-1A Statement of Candidate as a candidate for election to the position of Mayor of the City of White Sulphur Springs in Meagher County with the COPP on June 17, 2021 using the CERS electronic reporting system. On this Statement of Candidate, candidate Joyce certified that campaign expenditures would exceed \$500.00; and

WHEREAS, As a 2021 municipal (city) candidate who certified campaign expenditures would exceed \$500.00, candidate Joyce had C-5 campaign finance reports due on or before July 20 (covering all contribution and expenditure activity from the beginning of the campaign through July 15) and August 20 (July 16-August 14) of 2021; and

WHEREAS, On August 23, 2021, COPP Compliance Specialists emailed candidate Joyce to notify him that his campaign had yet to file required campaign finance reports. This email message requests that candidate Joyce "Please go into the CERS system...and file" the July 20 and August 20 campaign finance reports. The message also informs candidate Joyce that "You can file just one report...or you can file 2 separate report for July and August".

On August 24, 2021, COPP Legal Investigator emailed candidate Joyce to again notify him that his campaign had yet to file required campaign finance reports. This email notified candidate Joyce that:

You will need to log into the CERS system and file a C-5 campaign finance report disclosing all campaign contribution and expenditure activity from the beginning of your campaign through August 14, 2021. This required report must be filed by 5:00 PM on Friday, August 27, 2021. Failure to file by that date will result in an Order of Noncompliance being issued by Commissioner Mangan.; and

WHEREAS, despite public reporting calendars, COPP website and social media updates, instruction and guidance provided to Candidates by COPP staff, candidate Joyce has failed to:

- Candidate Joyce did not file a C-5 campaign financial report on or before July 20, 2021;
- Candidate Joyce did not file a C-5 campaign financial report on or before August 20, 2021;
- Candidate Joyce did not respond to COPP staff requests to file required reports on or before August 30, 2021.

A copy of the candidate's Statement of Candidate is attached.

IT IS FURTHER ORDERED, pursuant to §13-37-121, MCA, that is declared to be in NONCOMPLIANCE with the provisions of sections § 13-37-225, MCA and ARM 44.11.302; and

IT IS FURTHER ORDERED that a County Attorney or the Commissioner may, on failure by to submit appropriate campaign finance reports within 5 days after receiving this Order of Noncompliance, may initiate a civil action pursuant to sections §13-37-124 and §13-37-128, MCA; and

FURTHER, if is aggrieved by the issuance of this Order of Noncompliance, he may seek judicial review in District Court pursuant to section §13-37-122, MCA.
