ORDER OF NONCOMPLIANCE

To: Fred Wilburn

WHEREAS, the above named candidate, On June 4, 2021, Fred Wilburn filed a Declaration of Nomination and Oath of Candidacy with the Yellowstone County elections department; and

WHEREAS, Fred Wilburn filed a C-1A Statement of Candidate as a candidate for election to the position of Billings City Council, Ward 5 in Yellowstone County with the COPP on June 23, 2021 using the CERS electronic reporting system. On this Statement of Candidate, candidate Wilburn certified that campaign expenditures would exceed \$500.00; and

WHEREAS, As a 2021 municipal (city) candidate who certified campaign expenditures would exceed \$500.00, candidate Wilburn had a C-5 campaign finance reports due on or before October 20, 2021 (covering all contribution and expenditure activity from September 21, 2021¹ through October 14, 2021)

¹ Candidate Wilburn's last filed C-5 report was dated August 20, 2021 through September 20, 2021

and November 20, 2021 (October 25-at least the November 2, 2021 general election); and

WHEREAS, Candidate Wilburn did not file a C-5 campaign financial reports on or before October 20 or November 20, 2021; and

WHEREAS, On November 4, 2021, COPP Compliance Specialists emailed candidate Wilburn to let him know that the "October 20, 2021 (C5) report has not been filed. Please go in and file the C5 that was due. The next report is due 11/15/21 – that can be the closing report if you are done with the campaign, all debt paid and balance come to "zero". Thank you!"; and

WHEREAS, despite public reporting calendars, COPP website and social media updates, instruction and guidance provided to Candidates by COPP staff, candidate Wilburn has failed to:

 Candidate Wilburn did not file a C-5 campaign financial report for the reporting periods required for both the October 20 and November 20, 2021 report deadlines;

A copy of the candidate's Statement of Candidate is attached.

IT IS FURTHER ORDERED, pursuant to §13-37-121, MCA, that is declared to be in NONCOMPLIANCE with the provisions of sections § 13-37-225, MCA and ARM 44.11.302; and

IT IS FURTHER ORDERED that a County Attorney or the Commissioner may, on failure by to submit appropriate campaign finance reports within 5 days after receiving this Order of Noncompliance, may initiate a civil action pursuant to sections §13-37-124 and §13-37-128, MCA; and

FURTHER, if is aggrieved by the issuance of this Order of Noncompliance, he may seek judicial review in District Court pursuant to section §13-37-122, MCA.
