Gregory Schoby announced his candidacy for Great Falls City Commissioner on April 22, 2021 on Facebook (screenshot 1). He also started soliciting for contributions on Facebook on June 7, 2021 (screenshot 2). However, as of June 14, 2021, there is no record of a C-1A on file either in Montana CERS or in hard copy through MT COPP document search (screenshots 3, 4 & 5).

Schoby did not file a C-1A within five business days of filing his candidacy as required by Administrative Rules of Montana and the Montana Code Annotated.

Schoby violated Administrative Rules of Montana (ARM) 44.11.220 (2)

A candidate, whether or not the office for which the individual will seek nomination or election is known, shall file certification with the commissioner pursuant to 13-37-201, MCA, within five business days of becoming a candidate as defined by 13-1-101 MCA. ### Additional Sheet-Complaint Statement of Fact Dodd against Schoby

The Montana Code Annotated definition of candidate:

MCA § 13-1-101 (8) "Candidate" means:

- (a) an individual who has filed a declaration or petition for nomination, acceptance of nomination, or appointment as a candidate for public office as required by law;
- (b) for the purposes of chapter 35, 36, or 37, an individual who has solicited or received and retained contributions, made expenditures, or given consent to an individual, organization, political party, or committee to solicit or receive and retain contributions or make expenditures on the individual's behalf to secure nomination or election to any office at any time, whether or not the office for which the individual will seek nomination or election is known when the:
- (i) solicitation is made;

Schoby is a candidate as defined under the above MCA reference, therefore ARM 44.11.220 (2) applies to him.

The Montana Code Annotated requires each candidate to certify a campaign treasurer within five days after becoming a candidate.

- MCA § 13-27-201. Campaign treasurer. (1) Except as provided in 13-37-206, each candidate and each political committee shall appoint one campaign treasurer and certify the full name and complete address of the campaign treasurer pursuant to this section.
- (2) (a) A candidate shall file the certification within 5 days after becoming a candidate.

Schoby became a candidate on April 22, 2021 but has not filed certification of the campaign treasurer for his candidacy within five days.


