The following complaint refers to the C.5 Candidate Campaign Finance Report Filed by Juliane Lore on 10/20/21 for the period 4/16/21 - 19/20/21. I have enclosed a print out of this report for your reference.

- 1. This C.5 report was filed for the incorrect reporting period. The reporting period for this C.5 report was 9/16/21-19/14/21. (13.37.226)MCA
- 2. Due to the error: of filing this report for the incorrect dates, Miss Lore included entries on this C.5 form that needed to be reported on a C.7E form and is thus, non-compliant on the following two expenditures marked (a) and (b) on the enclosed print out. (13.37.226(d)) MCA
 - (a) Allegra Marketing for a color flier for mailing dated 10/15/21 for the amount of \$50000
 - (6) Laurel Outlook Newspaper for publication of an ad for \$180.00 The expenditure was dated 10/18/21.

3. My last complaint about Miss Lore's C.5 report has to do with the Candidate Contribution's section. In each entry she shows an In-Kind contribution which is equal to the amount of her personal deposit. I may be interpreting this incorrectly but to me it looks as if the businesses listed gove the Lore campaign a 50% discount on their services. If this is correct, this discount amount should have been reported as an in-Kind campaign donation/ contribution. Not only were these contributions unreported which violates (44.11.403) ARM but they also far exceed the campaign contribution limits (44.11.227) McA.
