After receiving your letter notifying us about the above captioned complaint alleging violations of Montana's campaign reporting and disclosure laws, we conducted a review of our campaign finance filings covering the 2021 General Election.

As part of that review, we discovered that certain independent expenditures, conducted by Montana Conservation Voters Action Fund, were not timely reported. Accordingly, we reached out to your office, and spoke with Kymberly Trujillo, receiving instructions on how to submit the past due reports.

Pursuant to those instructions, we submitted two type C6 reports through the Montana Campaign Electronic Reporting System, covering all relevant activity.
