WHEREAS, the above named candidate, On March 11, 2022, candidate Cashman filed a Declaration of Nomination and Oath of Candidacy with the Mineral County elections department; and

WHEREAS, Wayne Cashman filed a C-1A Statement of Candidate as a candidate for election to the position of County Coroner/Sheriff of Schools in in Mineral County with the COPP on March 17, 2022 using the CERS electronic reporting system. On this Statement of Candidate, candidate Cashman certified that campaign expenditures would exceed \$500.00; and

WHEREAS, As a 2022 county candidate who certified campaign expenditures would exceed \$500.00, candidate Cashman was required to file a C-5 campaign finance report on or before April 20, 2022, covering all contribution and expenditure activity for the period of March 16, 2022 through

April 15, 2022<sup>1</sup>; and

WHEREAS, On May 19, 2022, COPP Compliance Specialists emailed candidate Cashman to notify the campaign that it had yet to file the required April 20, 2022 C-5 campaign finance report. This email message goes on to state that:

By filing a Statement of Candidate with this Office certifying that campaign expenditures would exceed \$500.00, your campaign was required to file a C-5 campaign finance report on or before that April 20 date. COPP records indicate you have not yet filed this required financial report.

You will need to log into the CERS system and file the required April 20, 2022 C-5 campaign finance report. <u>This required report must be filed by the end of the day Friday</u>, May 20, 2022. Failure to file by that date may result in an Order of Noncompliance being issued by Commissioner Mangan.; and

WHEREAS, despite public reporting calendars, COPP website and social

media updates, instruction and guidance provided to Candidates by COPP

staff, candidate Cashman has failed to:

- Candidate Cashman did not file a C-5 campaign financial report on or before April 20, 2021;
- Candidate Cashman did not respond to COPP staff requests to file required reports on or before May 20, 2021.
- Candidate Cashman did not file a C-5 campaign financial report on or before May 20, 2021 for the period April 16 to May 14, 2022;

IT IS FURTHER ORDERED, pursuant to §13-37-121, MCA, that is declared to be in NONCOMPLIANCE with the provisions of sections § 13-37-225, MCA and ARM 44.11.302; and

IT IS FURTHER ORDERED that a County Attorney or the Commissioner may, on failure by to submit appropriate campaign finance reports within 5 days after receiving this Order of Noncompliance, may initiate a civil action pursuant to sections §13-37-124 and §13-37-128, MCA; and

FURTHER, if is aggrieved by the issuance of this Order of Noncompliance, he may seek judicial review in District Court pursuant to section §13-37-122, MCA.
