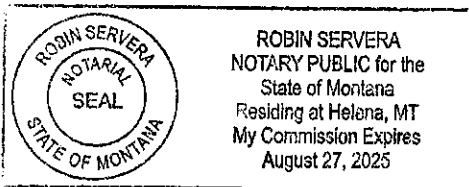

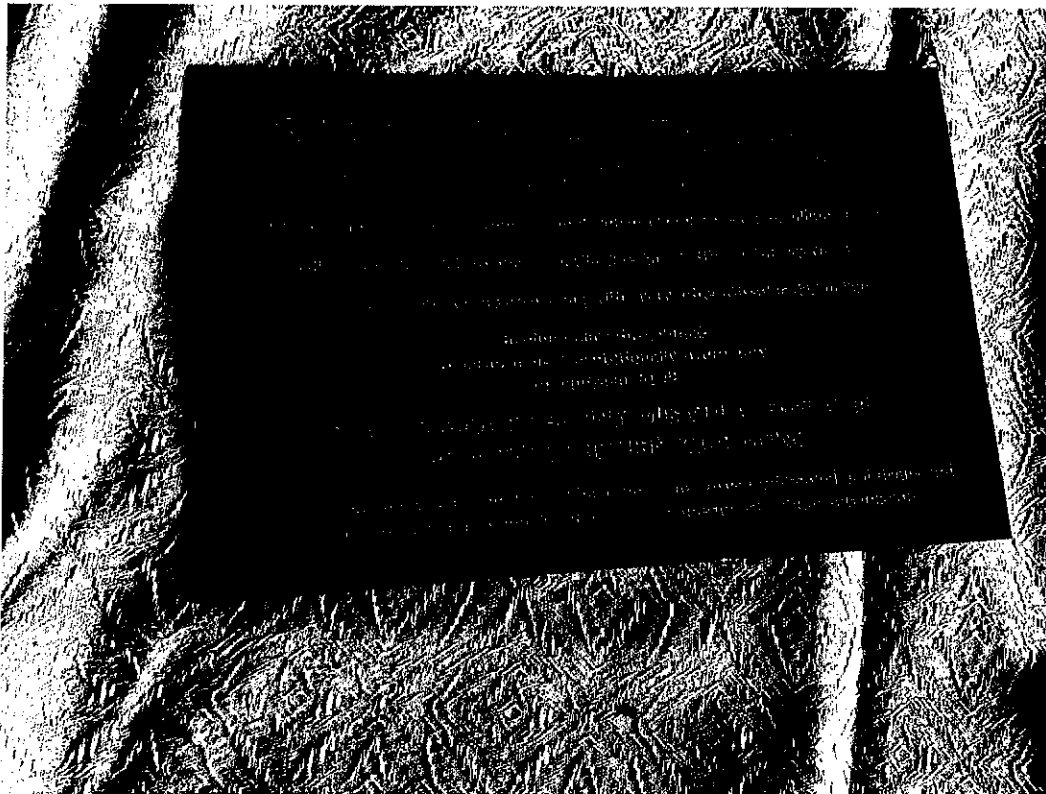

The mailer shown below was received by a voter on October 8, 2022, and there is no attribution disclosing who paid for or authorized the mailer. This complaint is brought against SD 49 candidate Brad Tschida, as he is named on this piece, though I acknowledge that this could have come from outside his campaign.

According to Mont. Code Ann. § 13-35-225 and 44.11.601(2), ARM, all election and electioneering communications are legally required to include attribution that identifies the entity that paid for the communication. These attributions must include:

- The name and address of the candidate or the name and address of the candidate's campaign;
- In partisan elections, candidates must also state their party affiliation or include the party symbol.
- An attribution using the name of the candidate's campaign must include the first and last name of the candidate if the name of the campaign does not include at least the candidate's last name.
- Additional information, such as the name of the campaign treasurer, may be included with the attribution language, but it is not required.
- Material that contains information about another candidate's voting record must include all the information specified in 13-35-225(3)(a), MCA.
