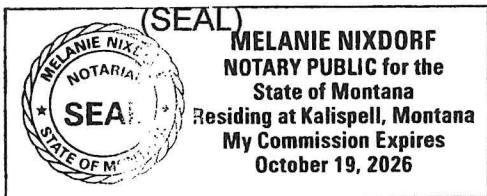

**Statement of Facts**

**Violation #1:**

Compassion for MT Families paid for a full page ad in the Daily Interlake (newspaper Kalispell, See attached exhibit #1) and according to MCA 13-35-225 (b) (see below) failed to disclose the name of the treasurer and the address of the committee. This is a violation that election materials not be anonymous. This ad has already been published and distributed.

(b) for election communications, electioneering communications, or independent expenditures financed by a political committee or a joint fundraising committee, the name of the committee, the name of the committee treasurer, deputy treasurer, secretary, vice chairperson, or chairperson, as designated pursuant to **13-37-201(2)(b)**, and the address of the committee or the named committee officer; and

**Violation #2:**

Compassion for MT Families paid for a full page ad in the Daily Interlake (newspaper Kalispell, See attached exhibit #1) and according to MCA 13-37-226 (2) (d) See below, expenditures of over \$500 after October 25th, must be reported within 2 business days. The ad came out on Sunday, October 30th, and the committee did not report the expenditure to the Daily Interlake in past reports or file a C7E in the time period required.

(d) within 2 business days of making an expenditure of \$500 or more that is made between the 25th day of the month before an election in which the political committee or the joint fundraising committee participates and the day before the election;
