The ACLU, a third-party registrar, mailed and advised applicants to mail a voter registration to an address other than the county election administrator's address in the applicants' county of residence.

Mont. Code Ann. 13-35-604 provides:

13-35-604. Return of voter registration and absentee ballot applications. A third-party registrar may not mail or advise an applicant to mail a voter registration or absentee ballot application to any address other than the county election administrator's address in the applicant's county of residence.

As you are aware, the statute it is specific to *an applicant*, and the number of violations is proportional to the number of applicants improperly mailed and/or advised. Our department and county election offices fielded numerous complaints from voters concerned over their privacy related to the ACLU's illegal voter registration activity.

With the proximity to the election, the activity ongoing, and the number of violations continue to increase, it is of paramount importance that your office promptly issues a sufficiency finding and sufficiency determination documenting regarding the ACLU's illegal voter registration activities.

Return Of Voter Registration And Absentee Ballot Applications

13-35-604. Return of voter registration and absentee ballot applications. A third-party registrar may not mail or advise an applicant to mail a voter registration or absentee ballot application to any address other than the county election administrator's address in the applicant's county of residence.
