

The latest finance reports for legislative condidates was due on March 21st 2000 at Spm MOT. Part of that finance report must have included that the condidate paid their filing fee. The COPP even sent an email to all condidates on March 11th (see attachment 1) saying "All condidates have at least paid their filing fee to the Secretary of State. That is part of finance reporting. This report ODES NEED to be done for the secretary of State to put your name on the ballot!"

As of 90m on March 22nd Mary Caferro has filed a report that claims she has 40 in donations and 10 in expenditures. That is clearly inaccurate because she at least paid the money for her filing fee NOH3-37 states that condidates must file reports with contributions and expenditures. Many Caferro has not reported any expenditures (see attachment 2) which is incorrect. She should have at least reported her filing fee.
