Marci Marceau has repeatedly violated Montana campaign finance laws over multiple reporting periods by failing to identify and report significant expenditures for her 2022 campaign for Legislature.

It is especially critical that aspiring law makers exhibit integrity, competence, and a willingness to comply with state law. Furthermore, failure to report campaign expenditures places opposition campaigns properly complying in a transparent manner at a strategic disadvantage.

Marci Marceau ordered and produced at least two bench advertisements (see attached dated photograph) on or before March 20th and never reported the expenditure on a C-5.

Marci Marceau purchased and utilized door hanging campaign literature (see attached photograph) which was never not reported on a C5.

Marci Marceau had produced and utilized two campaign banners (see attached dated photographs) which were never reported on a C-5. At least one banner was utilized at a Great Falls St. Patricks Day parade and another at the Great Falls Gun Show.

Additionally, Marci Marceau failed to report a form D-1 within the required reporting period.

Marci Marceau has violated Sections 13-37-226, 13-37-228, and 13-37-229 of the Montana Code Annotated.

The noted violations are limited to only known and obvious omissions. Given the extent and repeated nature of Marci Marceau's failure to adhere the law further investigation would likely reveal additional potentially significant discrepancies.

A thorough audit of Marci Marceau's campaign finances and banking records should be conducted. She should be fined under Section 13-37-128, MCA.
