BEFORE THE COMMISSIONER OF POLITICAL PRACTICES OF THE STATE OF MONTANA

Eaton v. Burroughs	DISMISSAL
No. COPP 2022-CFP-012	

On May 26, 2022, Jake Eaton of Billings, MT filed a campaign practices complaint against Brian Burroughs of White Sulphur Springs. The complaint alleged that candidate Burroughs did not include proper partisan affiliation on campaign material as required.

SUBSTANTIVE ISSUES ADDRESSED

Political party included in candidate communication attribution.

FINDINGS OF FACT

The foundational facts necessary for this Decision are as follows:

<u>Finding of Fact No. 1</u>: Brian Burroughs filed a C-1A Statement of Candidate with the COPP as a candidate for election to the office of County Commissioner in Meagher County on March 6, 2022. On the C-1A, candidate Burroughs indicated he was running as a Libertarian candidate. (Commissioner's Records.)

<u>Finding of Fact No. 1A</u>: Meagher County's 2022 county elections are partisan elections. (Commissioner's Records.)

Finding of Fact No. 2: On May 26, 2022, COPP sent email correspondence to candidate Burroughs notifying him that this Complaint had been received. The correspondence informed candidate Burroughs that the attribution complaint was merited because while candidate Burroughs had indicated he was a Libertarian candidate on the C-1A filed with COPP, the material

referenced by the complaint included a Republican symbol to denote his partisan affiliation. (Commissioner's Records.)

<u>Finding of Fact No. 2A</u>: On May 27, 2022, COPP staff spoke with candidate Burroughs via telephone. During this call, candidate Burroughs indicated that he had filed as a Republican candidate with Meagher County. (Commissioner's Records.)

Finding of Fact No. 2B: On May 27, 2022, Meagher County Elections Administrator Penny Plachy emailed the COPP a copy of candidate Burrough's Declaration for Nomination and Oath of Candidacy. Under the 'Name of Political Party' section, candidate Burroughs wrote 'Republican'. (Commissioner's Records.)

<u>Finding of Fact No. 3</u>: On May 31, 2022, candidate Burroughs Amended his C-1A Statement of Candidate. The Amended C-1A listed candidate Burrough's partisan affiliation as Republican. (Commissioner's Records.)

DISCUSSION

Under Montana law, election or electioneering communications financed by a candidate in a partisan election must "state the candidate's party affiliation or include the party symbol", §13-35-225(2), MCA. Meagher County's 2022 county elections are partisan, meaning partisan affiliation would be required on any election or electioneering communication financed by a candidate running for election to public office in that county (FOF No. 1A).

The complainant in this matter referenced an election communication financed by Meagher County Commission candidate Brian Burroughs that included a Republican symbol. The complaint argued that this partisan affiliation was inappropriate, as candidate Burroughs had indicated he was a Libertarian candidate on the C-1A Statement of Candidate filed with the COPP, not a Republican candidate (FOF No. 1). For this reason, COPP immediately contacted candidate Burroughs (FOF No. 2). In conversations with COPP

Compliance Specialists regarding this complaint, candidate Burroughs indicated that he had filed with Meagher County as a Republican candidate (FOF No. 2A). The Declaration for Nomination and Oath of Candidacy filed by candidate Burroughs with the Meagher County Elections Administrator does in fact list his political party affiliation as Republican (FOF No. 2B).

As candidate Burroughs listed his partisan affiliation as a Republican on the Declaration for Nomination and Oath of Candidacy filed with Meagher County, the complaint is dismissed. Inclusion of a Republican symbol on the campaign material appropriately disclosed candidate Burroughs' official partisan affiliation as required under Mont. Code Ann. §13-35-225(2). Candidate Burroughs has updated his C-1A Statement of Candidate filed with the COPP to appropriately reflect his partisan affiliation as Republican.

DECISION

The Complaint is hereby dismissed.


