Dear Mr. Mangan:

As requested, I have made copies of all receipts for the advertisements I purchased during the campaign season leading up to the June primary. In this letter, I will try to answer the items listed in the complaint as best I can. As a new, first-time candidate, I have clearly made some mistakes.

As to the first complaint, I filed for the office on January 13, 2022, but did not the form CA-1 until 3/15/22. That was caused by my misreading the requirements; I had not spent any money at that time, nor had I received any donations. I had not appointed a treasurer at that time either.

My first filing stated that I would not spend more that \$500 (as I expected no opponent), but I had to amended it later as I began to spend money on advertisement. I have included an email discussion with ccppphelp@mt.gov in May. But I have not filed any other reports since then.

The final complaint (about the ads not having identification) is true only in single incident. The first ad to appear in the Dillonite Daily did not have the names and address of the candidate; the folks at the Daily caught that for the next ad. The ad in Tribune had my name, but not a physical or a mailing address. It included only the city.

My campaign drew only a few contributions, nothing more than a \$100 for any one individual. In fact my "war chest" totaled \$340.

Although ignorance of the regulations is not an acceptable excuse, I'm afraid that is all I have in my defense.




