I am in receipt of your email correspondence with the complaint and the Commissioners response.

I have attached (at the very bottom of this email) the original document submitted to the printing company, Minuteman Printing in Missoula, MT. They are the same company that produced my first mailer, which contained the required attribution, and will be completing my subsequent mailings. As the original document notes, I included the requirement that an "Attribution" recognizing my campaign as the entity responsible for producing and paying for the mailer. It is apparent to me, and I will confirm with my printing company, that they simply failed to print the required "Paid For" "attribution" on this mailer, as they were directed and as they had on the first mailer they produced for me. The error on the part of the printer appears to be a "sin or omission", as my instructions required that the mailer contain the required "attribution", which my first mail piece did contain.

There were approximately 7,000 pieces that were mailed out on or about the 7th of October.

Going forward, I will require that a "final" final proof be sent to me to assure that the printer includes the required attribution. Since much of the dialogue with the printer was oral, aside from the artwork done that was submitted to them via email, I will assemble and keep all available correspondence related to this mailer.
