Pursuant to a Commissioner Of Political Practices (COPP) decision (No. COPP 2014-CFP-014, dtd 8 September 2014), Mr. David A. Ponte was prohibited from appearing "as a candidate on the ballot of any future election. . . . " In addition, Mr. Ponte was "conditionally banned as a candidate for future public office in Montana." (COPP Decision, pages 20 and 21).

Notwithstanding the COPP's prohibition, Mr. Ponte filed a Declaration for Nomination and Oath of Candidacy on February 29, 2016, with the Musselshell County, Montana, Election Administrator (See Exhibit A attached hereto). Mr. Ponte sought election as Precinct Committeeman for Musselshell County voting Precinct #5. Thereafter Mr. Ponte's name appeared on the June 7, 2016, Republican Party Primary Election Ballot (See Exhibit B attached hereto), and was thereafter elected to that public office.

Your Complainant herein searched the COPP website and was unable to find any record where the ban was lifted on Mr. Ponte's ability to appear on an election ballot or on his ability to hold public office. Thus your Complainant believes and therefore asserts that Mr. Ponte violated the prohibitions imposed by the COPP Decision, unlawfully appeared on the June 7, 2016, Primary Election Ballot, was unlawfully elected, and continues to unlawfully hold public office.
