## Candidate Finance Report Calendar Primary and General Elections

**Report form C-5 must be filed for each reporting period** to disclose all transactions, if any that occurred during the specific reporting period.

Filing Deadline	Reporting Period
April 5, 2019	Quarterly/Date of first contribution through March 31 <sup>st</sup>
July 5, 2019	Quarterly/April 1 <sup>st</sup> through June 30 <sup>th</sup>
October 5, 2019	Quarterly/July 1 <sup>st</sup> through Sept. 30 <sup>th</sup>
<p><b>Starting November 2019, all candidates—regardless of candidate type (e.g. statewide, district, city, etc.) – will follow the exact same C-5 reporting calendars. All candidate campaign finance reports will be due on the same dates.</b></p>	
January 5, 2020	Quarterly/Oct. 1 <sup>st</sup> through December 31 <sup>st</sup>
March 20, 2020	Monthly/January 1 <sup>st</sup> through March 15 <sup>th</sup>
April 20, 2020	Monthly/March 16 <sup>th</sup> through April 15 <sup>th</sup>
May 16th through June 2nd	File Form C-7 within 2 business days if a contribution of \$100 or more is received from a single source between between May 16th and June 2nd
	File Form C-7E within 2 business days if days if an expenditure of \$100 or more is made between May16th through June 2nd
May 20, 2020	Monthly/April 16 <sup>th</sup> through May 15 <sup>th</sup>
June 20, 2020	Post Primary/ May 16 <sup>th</sup> through June 15 <sup>th</sup>
August 20, 2020	Monthly/ June 16 <sup>th</sup> through August 15 <sup>th</sup>
September 20, 2020	Monthly/August 16 <sup>th</sup> through September 15 <sup>th</sup>
October 16 <sup>th</sup> through November 3 <sup>rd</sup>	File Form C-7 within 2 business days if a contribution of \$100 or more is received from a single source between October 16th through November 3 <sup>rd</sup>
	File Form C-7E within 2 business days if an expenditure of \$100 or more expenditure is made between October 16 <sup>th</sup> through November 3 <sup>rd</sup>
October 20, 2020	Monthly/September 16 <sup>th</sup> through October 15 <sup>th</sup>
November 20, 2020	Monthly / October 16 <sup>th</sup> through November 15 <sup>th</sup>
March 10, 2021	End of last period: November 16 <sup>th</sup> through March 5 <sup>th</sup>
September 10, 2021	End of last period: March 6 <sup>th</sup> through September 5 <sup>th</sup>
