

Complaint #1: Improper C-5 Filings

C-5 filing for period ending 9/30/16 was incomplete. Wendy Allen McGrath held a fundraiser on Sept 27th & had a large billboard advertisement up by Sept. 27th. Neither were reported until the C-5 filing for period ending 10/31/16. See Exhibits #1 & 2.

On both C-5 Filings there were no totals carried out for primary and general contributions by individuals. In fact, there are no totals to date for any contributions. See Exhibits #3 & 4.

Treasurers strongly advises against spending personal cash out of private accounts, Wendy spent \$3,608.75 out of "loans" during these two reporting periods. This leaves the reader wondering "where" + with "whom" did she make these campaign expenditures.

Complaint #2 : No disclaimer on campaign material.

Wendy has 2,500 copies of an endorsement letter being distributed across Butte-Silver Bow. There is no disclaimer.


