On Dec 17, 2013 Commissioner Obert was found guilty of violating closed-door meeting laws by District Court Judge Reynolds. This is a direct violation of the Montana open meeting laws and the Constitution of Montana and Commissioner Obert continues to violate these rights today.

Placing blame for her lack of responsible leadership, she has facilitated the illegal discharge of one very dedicated and knowledgeable county employee.
