

The Montana Democratic Party has issued multiple attack mailers (see attached), received by mail on October 27th or later, mentioning Ed Buttray in a negative fashion within the 10 days prior to the general election without providing any notice whatsoever to the candidate in clear violation of the Montana Clean Campaign Act MCA 13-35-402.

A Facebook Ad negatively portraying Ed Buttray by name was also observed on October 29th, also in violation of the Montana Clean Campaign Act MCA 13-35-402.

Complaints must be:

- delivered in person or by certified mail.


