



There are witnesses who observed Mr. Devers posting signs in businesses and they were also found taped to the decorative tree guards in our commercial district.

Mr. Devers is the manager of a mobile home park and recently attended a meeting of the Housing Committee to voice his opposition to a proposed Rental Inspection ordinance. His poster clearly names the candidates that are up for re-election.

Mr. Devers claimed that he is being paid to distribute these posters. It is not clear exactly who printed them or who is paying him for his services.
