

Pursuant to Montana Code Annotated § 13-37-225, 13-37-226, each candidate for statewide and state district offices shall account for all contributions received and expenditures made by or on behalf of the candidate by filing periodic reports. A report must be filed even if no money has been received or expended.

Dan Salomon did not file his C-5 form indicating all his campaign contributions and expenditures for his 2014 campaign for House District 93 by the required filing date, May 22, 2014. I, Frank Delgado, am formally filing a complaint against Dan Salomon for not adhering to the reporting laws that all candidates are required to file.
