Jedediah but only on the 29th of October ^{at 10:50 PM}


the mailers ^{may} have been disseminated

Requires notification to the candidate ON the day of dissemination,
published, or Broadcast, which would be the mail date.

I have attempted to acquire the date that these

from The Directory (the business from which they were
sent according to the postmark), and 2. By
walking into the Democratic party headquarters
here in Helena. I was not able to get the
date of dissemination from either source.




