

I have read the Commissioner's letters with great interest and was taken by the bold assertions below:

--- A candidate for public office in Montana is required by law to report and disclose contributions to, and expenditures by, their campaign. The Commissioner's office is tasked with ENSURING THAT MONTANA'S CANDIDATES AND PUBLIC OFFICIALS COMPLY with these campaign requirements.

--- Montanans charge each elected office as a "public trust", meaning we EXPECT THE PERSON IN THAT OFFICE TO ACT WITH HONESTY AND CONSIDERATION, just as we expect that in our own families.

--- Complaints are filed because unreported and undisclosed contributions or expenditures are, by law, considered to be UNFAIR.

--- The Commissioner's office has a companion, and greater, responsibility to the People of Montana to ENFORCE THE LAWS measuring the election-related "public trust" duty placed on elected officials.

j. p. Pomnichowski has been an elected official since 2008, and had been elected TWICE before violating 13-37-229 and 13-37-217. There is no excusable neglect for what she has done. Below is information from Pomnichowski's 2010 finance reports PROVING her failure to give address information for several contributors and taking over \$2,200 anonymously. On her January 1 to May 23 report she reported an unnamed "retired" person, with no address, gave her \$160. Another contributor with no name, address, or occupation gave her \$903.00. In addition to being anonymous, that is over the limit and a violation of 13-37-216. She parades her disrespect for the law on her reporting by marking "N/A" after some of the contributor names without addresses. Address information IS NOT "N/A" and EVERY candidate for public office has to give address information. Ms. Pomnichowski seems to think that rule doesn't apply TO HER. Her June 24 to October 16 report shows she received \$130 from a "homemaker" and another over limit and anonymous contribution of \$970. j. p. Pomnichowski is an elected official who has failed to fully report campaign contributions, which was unfair. It would be fair to say she did not act with honesty and consideration. The Commissioner should enforce the laws Pomnichowski ignored and put an end to her 2014 campaign.
