

I received the attached mailer the same week I received my absentee ballot. Several of my friends received similar oversized postcards at the same time they received their absentee ballots too. The pre-primary and post-primary campaign reports do not say that this mailer was paid for or how it was paid for.

A county-wide mailer to Missoula County absentee voters costs between \$4,000 and \$5,000.

Failure to disclose the expenditure and failure to disclose the funding source undermines the integrity our elections and are a serious violation that requires COPP's investigation.


