June 25 <sup>th</sup>	Post Primary/June 6 <sup>th</sup> through June 20 <sup>th</sup>

August 10 <sup>th</sup>	Monthly/July 6 <sup>th</sup> through August 5 <sup>th</sup>
September 10 <sup>th</sup>	Monthly/August 6 <sup>th</sup> through September 5 <sup>th</sup>
October 22 <sup>nd</sup>	Pre-General 1/September 6 <sup>th</sup> through October 17 <sup>th</sup>
November 1 <sup>st</sup>	Pre-General 2/October 18 <sup>th</sup> through October 27 <sup>th</sup>
Within 24 hours	File only if a \$200 contribution from a single source is received between October 28 <sup>th</sup> and November 6 <sup>th</sup>
November 26 <sup>th</sup>	Post General/October 28 <sup>th</sup> through November 21 <sup>st</sup> <i>(May also be the closing report if all debts are paid and no more campaign activity is anticipated; otherwise a closing report must be filed later.)</i>
March 10 <sup>th</sup> September 10 <sup>th</sup>	End of last period through March 5 <sup>th</sup> End of last period through September 5 <sup>th</sup>
