

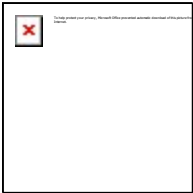

Pursuant to 13-35-225(3), MCA, I am submitting the following attribution statement for the text messages described below:

"Paid for by Montanans Organized for Education, Moffie Funk, Treasurer, PO Box 925, Helena, MT, 59624"

Montanans Organized for Education (MOFE) will distribute the following text messages on the dates listed below to roughly 7,053 voters in the Helena School District.

August 20, 2025

[FNAME], Jenny from Montanans Organized for Education. You should be receiving a ballot in the mail soon for the election on September 9.

On the ballot are two urgent and necessary school bonds - one for Helena's elementary school and one for Helena's High Schools. Our deteriorating school buildings aren't meeting the needs of our kids. Students at Kessler Elementary, which is 89 years old, have to wear winter coats inside due to inadequate heating. Lessons are disrupted in our high schools due to freezing temperatures in classrooms and pests that interrupt learning

These bonds are urgent and necessary. But don't take our word for it, hear from the teachers and students that use these buildings every day.
