Pursuant to 13-35-225(3), MCA, I am submitting the following attribution statement for the text messages described below:

Montanans Securing Reproductive Rights will distribute text messages to 23,585 individuals between the dates of June 4, 2024 and June 11, 2024. The content of the text messages is as follows:

INITIAL TEXT:

Hi {firstName}, it's Montanans Securing Reproductive Rights. We're fighting to protect reproductive rights in Montana, but we have only 3 weeks to get on the ballot. Will you help us collect signatures?

REPLIES:
