My name is Chris Fudacz with the Smarter Monforton Growth incidental committee.

We discovered an unintentional omission in material we had made. This omission was on yard signs, and also on printed material that was mailed to voters in School District 27 last week. We have not distributed anything since we learned of the mistake (4/16), and will not distribute anything that does not have our treasurer's name on it moving forward.




