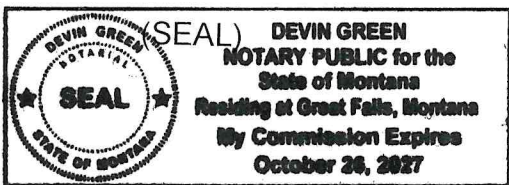

Statement of facts:

I'm attaching Jane Weber's campaign finance filing with the COPP for the accounting period of 07/11/2023-09/30/2023, filed on 10/04/2023. She is a candidate for Montana House District 19 in the 2024 cycle.

In the expenditure area of her campaign finance report, she notes that her campaign spent \$10,056 on "8 Billboards - service dates 5-6-24 through 6-4-24 and 10-7-24 through 11-5-24."

Please note the dates of 10-7-24 through 11-5-24 would coincide with expenditures meant for a general election period, not a primary election. This reveals that at least some portion, maybe even close to half, of this \$10,056 expenditure is attributable to the 2024 general election.

In the Accounting and Reporting Manual for Candidates and Treasurers (the "Green Book") referenced at the Montana COPP website, on page 4 in bold italics it states:

"During a primary election period, a candidate in a contested primary may receive contributions designated by the contributors as for the general election; however, those contributions are subject to the contribution limits for the general election and must be maintained in a separate account. General election contributions may not be used until after the primary election. If a candidate has accepted general election contributions and, thereafter, loses a contested primary election or finds that his/her campaign is uncontested in the primary, all general election contributions must be refunded to contributors." (see "Green Book" page 4 attachment)

A look at Weber's campaign finance report shows that all contributions on it have been primary campaign contributions. None were designated general election campaign contributions, and even if they had been, they would have to be reserved until after the primary election for use. So according to the candidate's own records, primary election contributions have been expended towards general election activities.

In addition, Administrative Rules of Montana 44.11.224 (c) states: "general election contributions received prior to the day of the primary election must be maintained in a separate account and shall not be used until after the day of the primary election" (see ARM 44.11.224 attachment).

It appears Candidate Weber has not done this although a portion of the contributions she has received are being used toward the general election, as noted previously.

Complaints must be:

- **signed**
- **notarized**
- **delivered in person or by mail.**

Immediately after designating a primary campaign depository and after appointing a campaign treasurer, a candidate must complete and file a Statement of Candidate, Form C-1 or C-1-A (see pages 18-19) with the Commissioner of Political Practices, using CERS (Campaign Electronic Reporting System), 13-37-201, MCA.

CAMPAIGN RECEIPTS

Contributions from supporters are the principal source of receipts. A contribution is defined by law, in part, as “an advance, gift, loan, conveyance, deposit, payment, or distribution of money or anything of value to support or oppose a candidate or ballot issue. . .” 13-1-101(9), MCA.

Contributions received by a candidate prior to and on the day of a primary election are presumed as primary election contributions and are subject to the aggregate contribution limits for the primary election.

During a primary election period, a candidate in a contested primary may receive contributions designated by the contributors as for the general election; however, those contributions are subject to the contribution limits for the general election and must be maintained in a separate account. General election contributions may not be used until after the primary election. If a candidate has accepted general election contributions and, thereafter, loses a contested primary election or finds that his/her campaign is uncontested in the primary, all general election contributions must be refunded to contributors.

In-kind contributions designated for the general election may not be accepted during the primary election period, 44.11.403, ARM.

Contributions received by a candidate after the day of the primary election are presumed general election contributions and are subject to the aggregate contribution limits for the general election³. A candidate *may* continue to receive contributions designated by the contributor as primary election contributions after the primary election and subject to the contribution limits *but only for the purpose of retiring primary election debt*, 44.11.224(2)(d), ARM. (For information regarding contribution limits, see pages 9 through 10 of this manual.)

All monetary contributions (cash or checks) received by anyone involved with a campaign must be transmitted to the treasurer (or deputy treasurer) and deposited within five days after the contribution is received, 13-37-207. This includes

44.11.224. DESIGNATION OF CONTRIBUTIONS FOR PRIMARY AND GENERAL ELECTIONS

(1) Aggregate contributions for elections in a campaign are limited according to 13-37-216 and 13-37-218, MCA, and as explained by ARM 44.11.222. An "election" in a campaign is either a primary election or a general election.

(2) For purposes of applying aggregate contribution limits per election the following apply:

(a) aggregate contribution limits for each election, as set forth in 13-37-216, MCA, apply to a primary election and to a general election as defined in ARM 44.11.222;

(b) time periods for filing reports of contributions and expenditures are set forth in 13-37-226 and 13-37-228, MCA. As a general rule, contributions received by a candidate prior to and on the day of a primary election are designated for the primary election and are subject to the aggregate contribution limits for the primary election; however, a candidate in a contested primary may receive contributions designated for the general election during the primary election period (except for in-kind contributions) subject to the contribution limits for the general election;

(c) general election contributions received prior to the day of the primary election must be maintained in a separate account and shall not be used until after the day of the primary election;

(d) all contributions received by a candidate after the day of the primary election are designated as general election contributions and are subject to the aggregate contribution limit for the general election, except that a candidate may continue to receive contributions designated for the primary election subject to the limits after that election only for the purpose of paying primary election debts. General election contributions shall not be used to pay primary election debt;

(e) leftover funds that were designated for the primary election may be used for general election purposes if all primary debt has been paid.

(3) A candidate for the legislature may use the same account in a campaign depository for primary and general election contributions received without being required to segregate those funds if:

(a) the candidate maintains records concerning when a contribution is received, and for which election the contribution is designated for; and

(b) the account balance does not drop below the amount of general election contributions received until after the day of the primary election.

(4) If a candidate receives contributions designated for the general election prior to the primary, and does not proceed to the general election, the candidate must return the contributions to the donors. These funds are not "surplus campaign funds" as defined in ARM 44.11.702.
