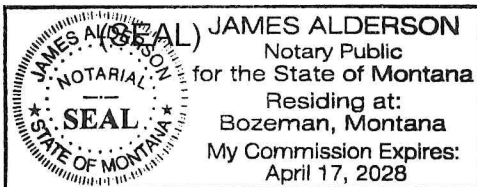

1. In Representative Marty Malone's 9/15/24 Report, the "Primary: Cash in Bank Ending Balance in this report" total should be \$0.00, not \$6,147.51, because that money is already reflected in the "Receipts / General" amount of \$11,9102.05. At present, the data shows a double-counting of that \$6.147.05.

2. As of October 7, 2024, Representative Malone has accepted a combined \$3,000 over contribution limits from various individuals, PACs, and Republican Central Committees who have donated to his campaign, as described in MCA 13-37-216 and ARM 44.11.227(1)(c) & (2)(e):
 - a). Representative Malone has accepted a total of \$4,200 from the Gallatin County, Park County, and Richland County Republican Central Committees since the April 20th C5 report. While he has refunded \$300 to the Park County Republican Central Committee and \$450 to the Richland County Republican Central Committee, he is still over the limit (\$2,250 combined from all Political Party Committees) by \$500.
 - b) Representative Malone has accepted a total of \$900 from Gayleen Malone, over the limit by \$450
 - c) Representative Malone has accepted a total of \$800 from Ken Walsh, over the limit by \$350
 - d) Representative Malone has accepted a total of \$900 from the Montana Contractors Association, over the limit by \$450
 - e) Representative Malone has accepted a total of \$850 from the Montana Farm Bureau PAC, over the limit by \$400
 - f) Representative Malone has accepted a total of \$900 from Ryan Malone, over the limit by \$450
 - g) Representative Malone has accepted a total of \$850 from Tom Barry, over the limit by \$400Attached are the relevant reports with all relevant contributions and expenditures highlighted.

3. Attached is a mailer received in direct support of Representative Malone's campaign, paid for by the "Montana Republican State Central Committee". Representative Malone has already received donations over the limit from Republican central committees. Mailers cost at least \$0.50-\$1.00 per piece, and presumably thousands were distributed throughout the district. The cost for them must be accounted for.

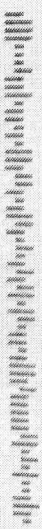
