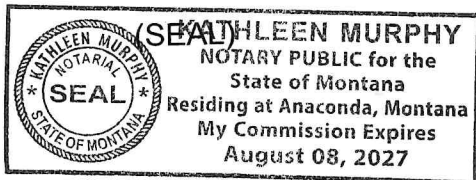

SCHREIBER AI DEEPPFAKE COMPLAINT


TRISH SCHREIBER IS MY OPPONENT FOR THE REPUBLICAN NOMINATION TO REPRESENT HD 76.
