Andrea Davis is a candidate for mayor of Missoula, having initially filed with the Commissioner of Political Practices on March 21, 2023. To date, she has filed five C5 reports (Four have been amended and two have been amended twice). To date she has also filed seven C7 reports and five C7E reports.

The Accounting and Reporting Manual for Candidates and Treasurers clearly defines the requirement for candidates and campaigns to accurately report expenses incurred and debts owed at the end of each reporting period. Page 18 of the manual states in part, A candidate uses Form C-5, Candidate Campaign Finance Report, to report their campaign's financial activities. A candidate also uses a special notice (Form C-7 & C-7E) for large contributions received and expenditures made, close to Election Day.

The Municipal Elections Odd Year Candidate Finance report Calendar states the C5 report with a filing deadline of October 20 covers the reporting period of September 16 – October 14. . From October 15 to the day prior to the General election a C7E report must be filed within 2 business days if an expenditure of \$125 or more is made between October 15 and the day prior to General.

Page 14 of the Accounting and Reporting Manual for Candidates and Treasurers states in part, "An expenditure is defined in law as "a purchase, payment, distribution, loan advance, promise, pledge, or gift of money or anything of value made by a candidate or political committee to support or oppose a candidate or ballot issue," 13-1-101 (18), MCA."

Page 14 of the Accounting and Reporting Manual for Candidates and Treasurers also states in part, "Reporting of campaign debts and obligations is one of the most commonly missed requirements during the reporting process. A candidate shall report the full name and mailing address of each person or entity to whom a debt or obligation is owed at the end of a reporting period, including the amount, date contracted, and purpose of each debt. If the exact amount is unknown at the time, the estimated amount shall be reported. (44.11.506, ARM)"

As is required by law, television and radio stations are required to post candidate's advertising contracts online on their FCC public file. The KPAX FCC

Public File currently shows a contract for the Andre Davis for Mayor campaign with a net expenditure to KPAX of \$4,594.25 for ads to run from October 16, 2023 to November 7, 2023. The attached contract shows that the contract was made on October 13, 2023. KPAX requires payment in advance before ads run.

Ms. Davis; C5 reports originally filed on October 20, 2023 and then amended on October 23, 2023 report contributions, expenditures and debts for the time period of September 16, 2023 to October 14, 2023. Both report and expenditure in the amount of \$\$1,453.50. There is no debt to KPAX reported on either report.

It is important to note that Ms. Davis has not filed any C7 or C7E reports since October 20, 2023. Her C7E report filed on October 20, 2023 does not report any expense or debt to KPAX.

Even after admitting that she had accepted illegal campaign contributions over the legal limit and admitting that she had filed inaccurate campaign finance reports, which resulted in refunding numerous illegal contributions, Ms. Davis continues to file inaccurate and deceptive campaign finance reports which hide a large expenditures or debt. Having only reported a \$1,453.50 expenditure to KPAX when the contract is in the amount of \$4,594.25, Ms. Davis is hiding \$3,140.75 in either expenditures or debts. This omission is such that one must question if Ms. Davis intentionally misreported an expenditure in order to gain an advantage in the General election.

The failure to report this expenditure or debt to KPAX is in direct violation of MCA 13-37-229 (2) I and MCA 13-37-229 (2) vi. The purpose of this law is to allow the general-public to know how and where candidates are spending campaign finances instead of having to search other reporting such as federally licensed television and radio stations. By illegally failing to report this expense or debt, Ms. Davis once again executed a scheme to conceal her campaign finance violations.

Included are copies of Ms. Davis's C5 report filed on October 20, 2023 with the reported expense to KPAX of \$1,453.50 highlighted and a copy of the KPAX contract with the total amount of \$4,594.25 highlighted.
