### **CAMPAIGN FINANCE COMPLAINT**

This Complaint is filed by Aaron Leas

This Complaint is filed against John Repke, candidate for Montana State Auditor, and the Repke for Montana campaign committee. The Address of both appears to be PO Box 1613, Whitefish, MT 59937.

Auditor Candidate and/or the Repke for Monana political campaign committee have clearly violated various provisions of Montana's campaign practices laws, namely Montana's campaign disclosure laws. To wit: Repke and/or his political campaign have purchased highway billboards and yard signs that are available for public viewing. However, neither yard signs nor the highway signs have the required disclosures for either (1) Repke's political party affiliation or (2) the proper attribution for who or which entity paid for the materials. See, MCA Section 13-35-225, MCA.

### Foundational Facts:

- 1. John Repke is the Democrat Party candidate for State Auditor in the 2024 election. See, Exh. 1
- 2. The election for State Auditor is a partisan election.
- 3. Repke or the Repke for Montana campaign for Auditor has purchased multiple highway signs for the Repke campaign in various locations around Montana, including known locations around Cascade, East Missoula, West Billings, and the Garrison Junction. See photo attached hereto as Exh. 2.
- 4. Repke or the Repke for Montana campaign for Auditor has purchased campaign yard signs, which are displayed at various locations around Montana. See photo attached hereto as Exh. 3
- 5. Nowhere on the highway signs or yard signs is Repke's political party affiliation identified.
- 6. Nowhere on the yard signs is there a proper attribution statement, i.e. a proper 'Paid for by' statement/attribution.

### **VIOLATIONS:**

- a. As expressly set forth in Montana law and in the COPP accounting and reporting manual for candidates and campaign treasurers, all campaign materials, including yard signs and billboards, must include a 'Paid for by . . .' attribution statement (i.e. the disclaimer). See, Page 33.
- b. All election materials are required by 13-35-225, MCA, to clearly and conspicuously include the appropriate attribution language.
- c. As noted above, neither the Repke yard signs or highway signs contain the legally required disclosure language. This constitutes two separate violations of Montana's campaign finance disclosure laws by Repke and/or the Repke for Montana Campaign.
- d. In addition, nowhere on these campaign materials is Repke's party affiliation identified.
- e. As clearly stated in the COPP accounting and reporting manual for candidates and campaign treasurers, in partisan elections, such as the Auditor election, election communications must state either the candidate's party affiliation or include the candidate's party symbol. See, Pages 34-25.
- f. Repke's failure to identify his party affiliation on his signs constitute two additional violations of Montana's campaign disclosure laws.

As succinctly stated on the COPP webpage, Montana's campaign finance laws protect the public's right to know who is paying to finance elections. Every Montanan must be able to look at any paid political communication and be able to know who financed the material.

As a candidate, John Repke is and was required to disclose his party affiliation and who paid for his yard and highway signs. Repke has gone out of his way to ensure that Montana citizens are deprived of critical information as to who is funding the payment for Repke's campaign materials, thereby depriving Montana voters of information related to transpiring reporting of money in Montana elections and depriving Montana voters of accountability in Montana's democratic process.

Repke has been a candidate for office multiple times. Repke has also been a vocal champion of full disclosure of campaign spending and reporting. Yet, despite Repke's claims that he is for full campaign reporting and disclosure, Repke himself has failed to meet even the most basic of Montana's campaign disclosure requirements during his run for State Auditor

As such, the concept of excusable neglect cannot be used by Repke or the COPP to absolve Repke's and/or the Repke for Montana Campaign committee for the multiple violations of Montana law set forth above. If anything, the fact that Repke has extensive experience in the area of campaign finance law in Montana necessitates that he be held to a higher standard and sanctioned accordingly.

### **RELIEF REQUESTED:**

- That Repke/the Repke for Montana Committee be determined to have violated Montana's campaign finance laws in that their yard and highway signs fail to include the campaign disclosure disclaimers required by Montana law.
- That the Repke/Repke for Montana Committee be determined to have violated Montana's campaign finance laws in that their signs fail to include any identification of Repke's party affiliation
- These campaign disclosure violations have been continual and ongoing as the proper legal disclosures have been omitted since the creation of the signs.
- That Repke be immediately directed to take down his highway signs and that Repke be directed to both stop disseminating his non-compliant yard signs and to collect those signs already distributed.
- That a civil penalty be assessed against Repke/the Repke Campaign.
