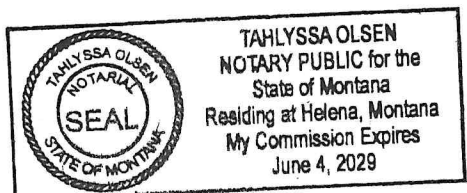

FORMAL COMPLAINT

II. RESPONDENT(S)

Primary Respondent: "A Handful of Helena Friends Who Care" — identity and legal status unknown; the entity that produced, financed, and distributed the publication described herein.

Additional Respondents/Persons of Interest: Waking Giant (Helena, MT; founder Brandi Swingley); and any other natural person or legal entity that contributed to the financing or distribution of the subject publication.

Date of Complaint: May 22, 2026

III. DESCRIPTION OF THE PUBLICATION AT ISSUE

The publication at issue is a 26-page printed political booklet titled "The Local Impact Book, Part 1" (hereinafter "the Booklet"), bearing the notation "April 2026, Helena, MT" and attributed on its cover only to "A Handful of Helena Friends Who Care." The Booklet was distributed to the public in Helena, Montana, in April 2026 — within the 60-day electioneering communication window preceding the Montana primary election scheduled for June 2, 2026.

Physical copies of the Booklet have been obtained and are attached hereto as Exhibit A. The Booklet contains, among other content:

- Express advocacy for Constitutional Initiative 132 (CI-132), the "Yes on CI-132" campaign, with a dedicated full page promoting the Montanans for Nonpartisan Courts ballot committee and its messaging;
- An explicit call to action directing readers to "Join the Democratic Party," "Push for progress," "Hold office within the party," and "Run for office";
- Extensive anti-Republican and anti-Governor Gianforte content, including by name: attacks on the Governor's flat-income-tax proposal, a characterization of the Governor as a "billionaire governor," and a description of his landmark legislation as "the Billionaires' Big Brutal bill";
- Identification of the June 2, 2026 primary election date with a QR code to voter registration and election forms;
- Organization profiles, QR codes, donation solicitations, and calls to action for approximately 20 progressive organizations and activist networks, including Waking Giant, Indivisible Helena, Moms Demand Action, Montana 4 Palestine, and others;
- A solicitation of donations to an account identified as "Montana Immigrant Fund, Valley Bank Acct# 330000255059" — an entity that does not appear in the IRS Tax-Exempt Organization Search, the Montana Secretary of State business registry, or the Montana DOJ charitable trust registry.

The Booklet contains no "Paid for by" attribution of any kind, no name of a responsible party, no address, and no COPP committee registration number. The nominal producer, "A Handful of Helena Friends Who Care," appears in no business, nonprofit, or campaign-finance public record in Montana.

IV. ALLEGED VIOLATIONS

A. Violation of MCA § 13-35-225 — Anonymous Election Material

MCA § 13-35-225 provides that "[a]ll election communications, electioneering communications, and independent expenditures must clearly and conspicuously include the attribution 'paid for by' followed by the name and address of the person who made or financed the expenditure for the communication."

The Booklet constitutes an "election communication" and/or "electioneering communication" under MCA § 13-1-101 because it:

- Expressly advocates a position on CI-132, a ballot issue to be decided at or following the June 2, 2026 primary election;
- Expressly advocates partisan political affiliation and voter registration action in proximity to the primary;

- Expressly references the June 2, 2026 primary election with voter-registration QR codes;
- Names and opposes by name a sitting elected official (Governor Gianforte) in the context of his pending legislative priorities.

The Booklet contains no "Paid for by" attribution whatsoever. This is a plain violation of § 13-35-225 on its face. Under ARM 44.11.601, the responsible party is required to: (1) file notification with the Commissioner within two business days of discovery; (2) bring the material into compliance; and (3) withdraw non-compliant materials from circulation.

Complainant requests that the Commissioner issue a Notice of Deficiency to the producing party and compel immediate compliance and cure.

B. Failure to Register as a Political Committee — MCA §§ 13-37-201, 13-1-101

Under MCA § 13-1-101(29), an "incidental committee" is any political committee not primarily organized for political purposes that nonetheless makes a contribution or expenditure in support of or in opposition to a candidate or ballot issue. Under MCA § 13-37-201, any political committee must file a C-2 Statement of Organization within five days of qualifying.

A political committee "qualifies" under Montana law upon making or receiving a single contribution or expenditure exceeding \$250 for election purposes. A 26-page full-color printed booklet distributed to the public at scale necessarily costs well in excess of \$250 to produce and distribute. The producing entity — "A Handful of Helena Friends Who Care" — therefore became a political committee upon incurring those costs and was required to register with the COPP no later than five days thereafter.

A search of the COPP Campaign Electronic Reporting System (CERS) discloses no registration by "A Handful of Helena Friends Who Care," "Waking Giant," "Waking Giant Helena," "Local Impact Book," or any variant thereof. No C-2 Statement of Organization, C-6 campaign finance report, or other COPP filing was identified.

Failure to register is a violation of MCA § 13-37-201 and subjects the responsible party to civil penalties under MCA § 13-37-128.

C. Anonymous Contributions — MCA § 13-37-217

MCA § 13-37-217 prohibits any person from making or accepting anonymous contributions to a political committee. Because the financing party has not been identified, all contributions to the production and distribution of the Booklet are effectively anonymous contributions. If the Booklet is found to have been funded by a registered committee (e.g., Montanans for Nonpartisan Courts), any unreported in-kind contribution would separately violate MCA § 13-37-229 (failure to report in-kind contributions) by that committee.

D. Potential Coordination with Registered Ballot Issue Committee

Montanans for Nonpartisan Courts (Treasurer: Kellen Alger, P.O. Box 87, Helena, MT 59624) is the registered ballot issue committee supporting CI-132. The Booklet includes a prominent full-page feature promoting CI-132 using imagery and messaging that closely mirrors Montanans for Nonpartisan Courts' public materials, and several organizations identified in the Booklet (including Catalyst Montana) are publicly identified as coalition members of the CI-132 campaign.

If the Booklet was coordinated with Montanans for Nonpartisan Courts, the production and distribution costs represent in-kind contributions to that committee that must be disclosed on a C-6 report. Complainant requests that the Commissioner investigate whether any such coordination occurred and whether Montanans for Nonpartisan Courts has properly reported the in-kind value of this publication.

E. Unregistered Charitable Solicitation — Montana Immigrant Fund

The Booklet publicly solicits monetary donations to an account identified as "Montana Immigrant Fund, Valley Bank Acct# 330000255059." A search of the Montana DOJ Office of Consumer Protection charitable solicitation registry, the IRS Tax-Exempt Organization Search, and the Montana Secretary of State business entity database discloses no registration for the "Montana Immigrant Fund" as a nonprofit, charitable organization, or political committee.

While the Commissioner's primary jurisdiction is campaign finance, to the extent any portion of the solicited funds are used for political activity (including distribution of election communications such as the Booklet itself), that entity becomes an unregistered political committee under Montana law. Complainant flags this for the Commissioner's attention and notes that a separate referral to the Montana DOJ Office of Consumer Protection and the IRS may be warranted.

V. REQUESTED RELIEF

Complainant respectfully requests that the Commissioner:

- Issue an immediate Notice of Deficiency to the producing party under ARM 44.11.601 requiring attribution compliance within two business days and withdrawal of non-compliant materials from circulation;
- Open a formal investigation into the identity of the financing party or parties behind "A Handful of Helena Friends Who Care" and the Booklet's production;
- Determine whether the producing entity constitutes an unregistered political committee or incidental committee under MCA § 13-1-101 and § 13-37-201, and

if so, compel immediate C-2 registration and C-6 disclosure of all contributions and expenditures related to the Booklet;

- Investigate whether the production and distribution of the Booklet was coordinated with Montanans for Nonpartisan Courts, and if so, whether that committee has properly reported the in-kind value as required by MCA § 13-37-229;
- Assess civil penalties against the responsible party or parties under MCA § 13-37-128 for each identified violation;
- Refer the Montana Immigrant Fund solicitation issue to the Montana DOJ Office of Consumer Protection and IRS, as appropriate, if evidence of unregistered charitable or political fundraising is found;
- Take any other action the Commissioner deems necessary to ensure public transparency and compliance with Montana's campaign finance laws.

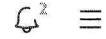

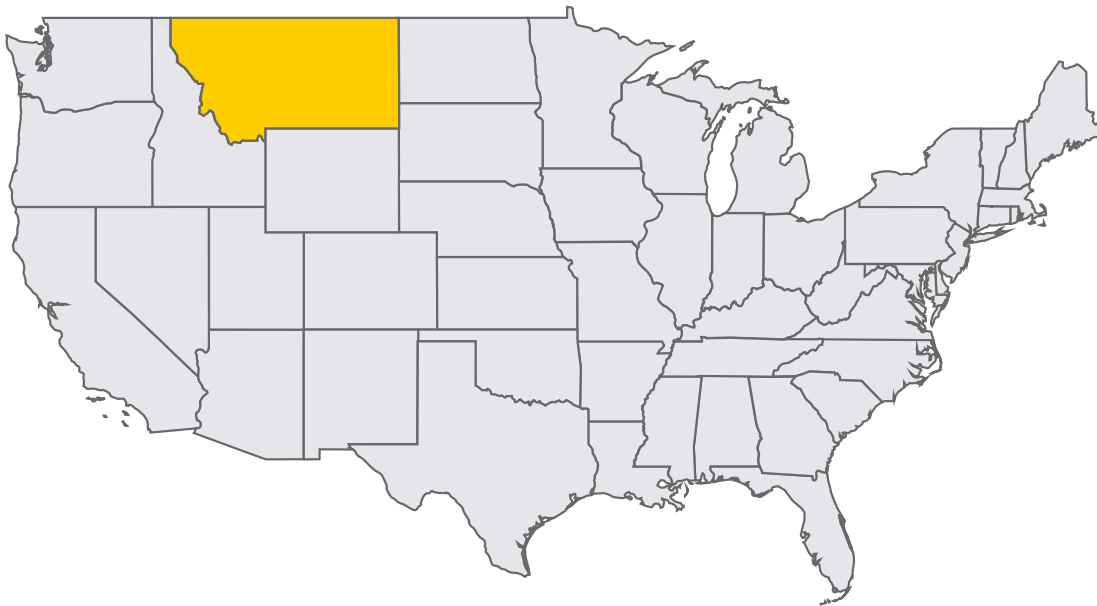

 - Write to the governor, state legislature, department heads

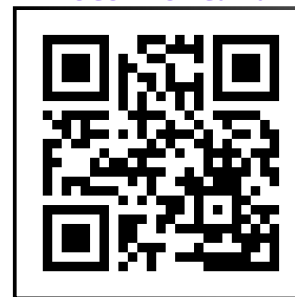

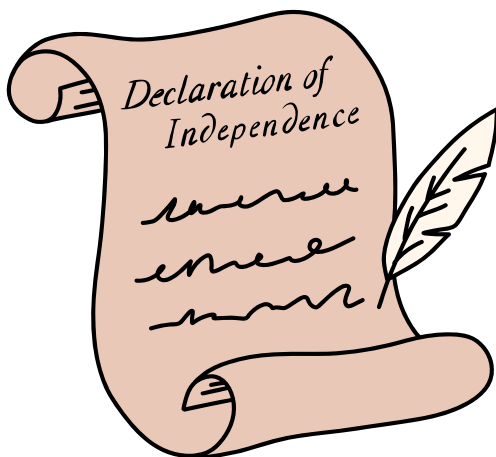

History

Throughout our history, the United States has chosen to erase the contributions of women, indigenous, black, queer, and immigrant people and cultures. Our history is taught as a series of dates and the heroics of white men. By leaving out the contributions of so many, we set ourselves up to consider that no one else made substantial contributions.

Did you know about the enslaved Black man who escaped, stole a confederate ship, and sailed north, not only to freedom but to fight in the Civil War for the freedom of all enslaved people? Or that the Mercury astronauts would not launch without a Black woman checking all the calculations? Or that a woman founded pediatric cardiology and a Black man without any professional education created the procedure to cure cyanotic heart disease (blue baby syndrome)? Or that without a transgendered woman we would not have microchips that led to personal computers and cell phones? Or that native people and their languages are credited with code talking that was never broken during WWII? Or that democracy existed in North America for generations before the United States constitution?

We encourage you to explore history in a way that fills in the gaps of an education system that promoted a very simplified version of the facts. Celebrate learning about cultures and people that you were previously unaware of, and recognize the contributions of all those who came before us to ensure the opportunity for every person in the future to reach their full potential.

In our struggle for democracy and self determination, we must never leave anyone behind again. If the history we were taught has shown us one repeating theme, it is that when we do not lift everyone up, we can be manipulated by unwarranted prejudices to fight each other, rather than those who try to reduce our potential for their own wealth and power.

Judiciary

Partisan elections for judges lead to less blind justice and more “pay to play” with outcomes that favor donors. Yale Law School lecturer and defense lawyer Stephen Bright said “courts have a responsibility to protect a defendant’s constitutional rights without political pressure,” but partisan elections inject politics and create judges influenced by political parties and large donors, as data from states with partisan judicial elections show. This cannot happen in Montana!

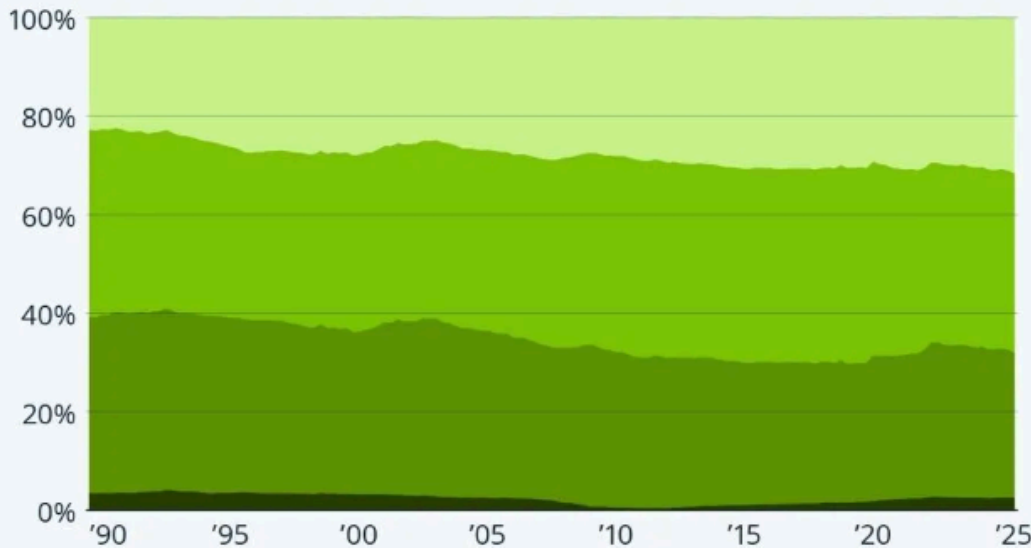

Wealth inequality is the unequal distribution of assets—such as property, stocks, and cash minus debts—among a population, resulting in a significant, often growing gap between the ultra-wealthy and the rest of society. In the U.S., the top 1% holds over 30% of total wealth, while the bottom 50% owns just 2.5%, often fueled by capital gains, tax policies, and stagnant wages.

In 2009, the last time minimum wage was raised, the goods analyzed cost \$211.933. In 2026 those goods cost \$326.588, an increase of about 54%. For a federal minimum wage worker, they would have to work over 2 additional 8 hour days to pay for these increases.

Productivity vs Wage Growth

Increases in productivity have long been associated with increases in compensation for employees. For several decades beginning in the 1940s, productivity had risen in tandem with employees' compensation. However, since the 1970s, productivity and compensation have steadily diverged.

CEOs vs. Workers: Diverging Paths Since 1978

Perhaps the most revealing comparison comes from juxtaposing executive pay with worker compensation:

- Typical worker pay (1978–2024): Grew just 26%.
- CEO realized compensation (1978–2024): Surged 1,094%.
- Productivity growth (1978–2024): 80.5%, far higher than worker pay but still dwarfed by CEO pay growth.

This divergence has reshaped the income distribution in corporate America, fueling debates around fairness, labor relations, and the responsibilities of leadership in an era of widening inequality. It has macroeconomic and political dimensions:

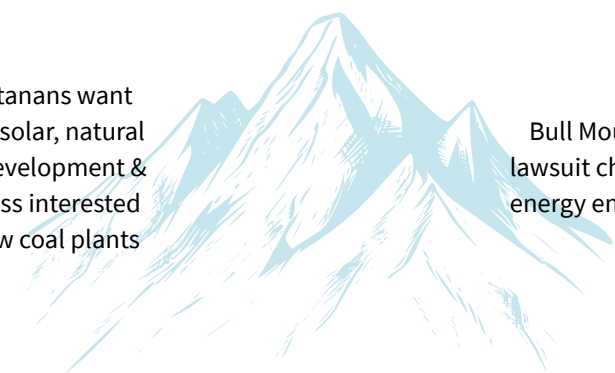
- **Wealth Concentration:** Extreme executive pay contributes to wealth inequality, reshaping consumer demand and social mobility.
- **Political Scrutiny:** Lawmakers on both sides of the aisle increasingly spotlight pay ratios as symbols of inequality. Some propose higher taxes on excessive compensation or linking corporate tax rates to pay ratios.
- **Social Cohesion:** Worker dissatisfaction, union activity, and public skepticism of corporate leadership often intensify when pay disparities widen.

Environment

Montanans know that our way of life depends on healthy land, clean water, and a stable climate, but powerful corporate interests treat our home as a sacrifice zone for short-term profit. From mining companies to fossil fuel corporations and speculative developers, the same players driving inequality and division are also polluting our rivers, draining our aquifers, and putting our communities at risk from drought, fire, and extreme weather. They spend big money to convince us that environmental protections kill jobs, when in reality, outdoor recreation, agriculture, and restoration work are some of the most reliable sources of good local jobs we have. When we are fighting each other over false “environment vs. economy” choices, we are less likely to notice who is actually cashing in on degraded land and poisoned water.

In Montana, we are already living with the consequences. Longer fire seasons, smoky summers, low snowpack, and shrinking streamflows threaten ranchers, recreation workers, and small businesses alike. Corporations push for weaker safeguards so they can cut corners on cleanup, offload their costs onto downstream communities, and walk away when the boom ends. They use front groups and slick PR campaigns to make it look like “grassroots support,” but the funding and strategy trace back to the same billionaire networks that are attacking workers, public schools, and democracy itself. Meanwhile, ordinary Montanans are the ones who sandbag during floods, evacuate during fires, and pay higher insurance premiums when things go wrong.

The good news is that Montanans have a long tradition of standing up for the land and water we share. From stopping cyanide heap-leach mines to passing our strong constitutional right to a clean and healthful environment, people here have proven that when we stand together, we can beat the lobbyists and lawyers. Local groups, tribal nations, landowners, and everyday neighbors are organizing to defend clean water, hold polluters accountable, and invest in renewable energy and restoration work that create real jobs rather than boom-and-bust promises. Every comment letter, public meeting, and conservation easement is part of the same fight to keep decisions in the hands of the people who live here, not the corporations that see Montana as a line item on a balance sheet.

Food

1 in 7 residents of Helena struggles with hunger.

1 in 5 Helena children don't have enough to eat.

1 in 6 seniors wonder when their next meal might be.

There are over 400 school-aged kids in Helena who do not have secure housing. If you don't know where you will be spending the night, you don't know where your next meal is coming from either.

Helena Food Share can help! How to get food in 3 easy steps:

1. **Visit the Grocery Share Market** – Come to the Market during regular operating hours. There are no age or income requirements to shop.
2. **Check in at the Welcome Desk** – On your first visit, a trained volunteer or staff member will help you complete a short intake form. All information is kept confidential. You will be asked to update your information once a year.
3. **Shop for Groceries** – You may shop for food once per week.
 - Weekly items may include produce, refrigerated and frozen foods, bread, sweets, and extras. Availability and limits depend on the food we have that week.

Once each month, you may add monthly items—such as canned and boxed foods, grains, frozen meat, and dairy—to your weekly shop. Monthly item limits are based on your household size.

Waking Giant members started several Little Free Pantries around town and additional pantries are planned. These pantries play an important role in filling in gaps for families who are food insecure. Churches and other groups are beginning to help with keeping the shelves stocked. 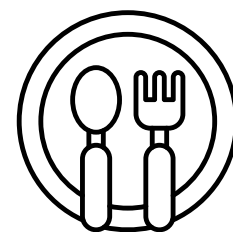

Housing

In 2024, 90% of families with income <\$20k and 60% of families with income between \$20–50k spent >30% of wages on housing. For financial stability, it is widely recommended to spend less than 28–30% of wages on housing. One of every three households are living paycheck to paycheck – meaning they are spending over 95% of their pay on necessities, per Bank of America Institute (USA Today, 11/2025). Meanwhile, PNC Bank’s annual Financial Wellness in the Workplace Report shows that 67% of workers now say they are living paycheck to paycheck (Newsweek 9/2025). These factors explain why so many people find themselves without stable housing.

Poverty guidelines are often used to determine eligibility for food and housing programs. The poverty guideline in the lower 48 (\$15,960) is now MORE than a full-time, federal minimum wage earner (\$15,080). Montana’s minimum wage is tied to a conservative cost of living estimate and has risen to \$10.85 (\$22,568/ year or approximately \$1800/month after taxes) in 2026. Though Montana’s average cost of living ranks 33rd , our larger towns are among the most expensive in the country to live.

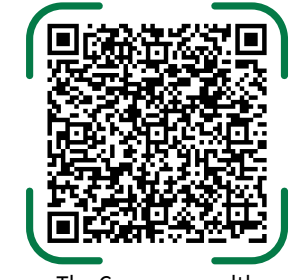

At the current cost of \$891M/day, if the Iran war continues for 4 months, we will spend enough money to cover the Medicaid cuts for an entire year. Meanwhile, \$1.2B of \$50B is coming to Montana to invest in changes to rural healthcare from the same Billionaires' Big Brutal bill that cut Medicaid. This is a one-time infusion of funds that will mask the impact to rural hospitals. It may extend the life of rural healthcare past the next election, but it does not address the root cause of the risks to rural healthcare: unstable, inconsistent funding and revenue. Rural hospitals and clinics are already closing or shifting away from primary care to strictly emergency care across the country and across Montana.

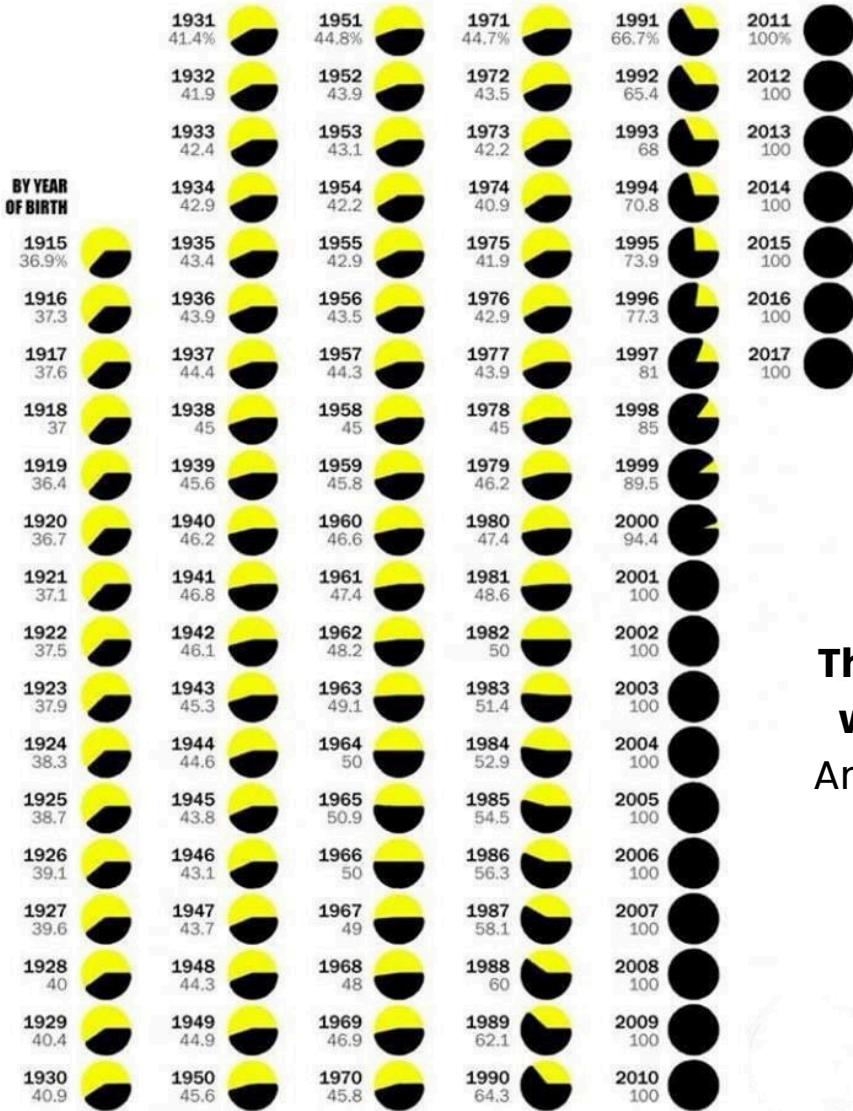
"Cuts" to Medicaid are a result of increased bureaucracy, time, and effort forcing people to give up on benefits that could help them. The majority of people on Medicaid already work, unless they cannot because they are children, students, or disabled. Georgia currently has work requirements for Medicaid. They spent \$54M in administrative costs, while only providing \$26M in medical assistance in the first few years. Meanwhile, glitches in the tech denied eligibility and there were not enough human staff to review complaints. Results in Arkansas, where work requirements were also implemented for approximately 9 months, found that the number of uninsured people rose while having no impact on employment. Despite all evidence pointing to work requirements increasing government spending and bureaucracy, reducing benefits, negatively impacting Montana's rural healthcare, and having no positive impact on employment, it is now nationwide, thanks to the Billionaires' Big Brutal bill.

Meanwhile, multiple studies found that Medicare for All would save tens of thousands of lives a year while reducing U.S. health care spending by hundreds of billions per year. The US spends approximately twice what its peer nations do on healthcare. Excess U.S. health spending was associated with factors such as administrative costs of insurance (~15% of the excess), administrative costs borne by providers (~15%), and prescription drugs (~10%). These excess costs are driven by private insurers, inconsistent coding and coverage between insurers, and basic corporate greed.

War

This graphic shows major military actions up to 2017, originally published by the **Washington Post**. Nearly 20 years after the United States' invasion of Afghanistan, the cost of its global war on terror stands at \$8 trillion and 900,000 deaths, per the Costs of War project at Brown University. That money could have funded the State Department and USAID for 127 years at the level requested by the President in 2024.

Since January 2025, the Trump regime has threatened Panama, Cuba, and Greenland with military intervention or takeover. It has launched strikes on boats off the coast of Venezuela that posed no threat to the United States, including a "double tap" strike on a vessel that killed survivors at sea. It also conducted a military operation inside Venezuela to remove the country's leader and has since entered into a war with Iran.

The war in Iran has cost roughly \$890 million per day and has already resulted in significant loss of life, including approximately 150 young girls and staff killed in a strike on a school. An additional 87 naval personnel were killed when a U.S. attack sank an Iranian ship near Sri Lanka—nearly 2,000 miles from Iran—as it returned from a ceremonial event hosted by India.

Decisions to strike schools and unarmed vessels, and to act unilaterally without allied support, are damaging U.S. relationships and weakening global security.

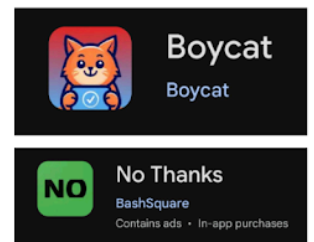

Private Prisons

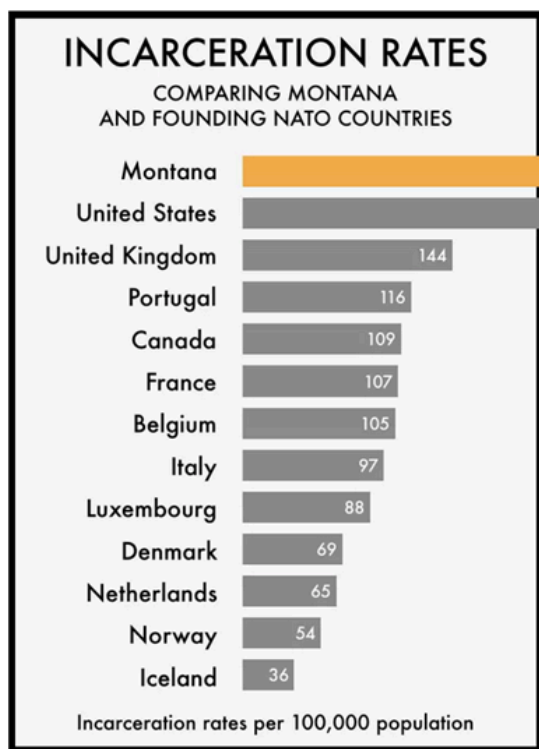
The Prison Industrial Complex is the system that governments and private agencies use to exploit incarcerated individuals for personal gain. Unlike traditional public prisons operated by government agencies, private prisons are managed by profit-driven entities. The prison industry is worth over \$80 billion and includes thousands of corporations.

In fact, Montana has 3 contracts with CoreCivic, the second largest private corrections company in the U.S. with a reported revenue of \$2 billion in 2025; they also opened 9 new detention centers for ICE to use.

Justice should never be administered through the prism of profit.



Montana has an incarceration rate of 758 per 100,000 people (including prisons, jails, immigration detention, and juvenile justice facilities), meaning that it locks up a higher percentage of its people than any independent democratic country on earth.



Montana Profile

Rather than trying to reduce that number, the legislature continues to invest in more prisons. In the 2025 legislative session, 2 bills allocated **\$436 million** towards the DOC, including \$250 million for a new women's prison (HB833).

It's a cycle that has to stop, the prison industry reaps financial benefits from the exploited labor of incarcerated individuals who often live in poor living conditions. They use that money to lobby at the state and federal levels for government contracts and to influence legislation favorable to their business model.

IF YOU HAVE ANY CONTACT WITH ICE OR THE POLICE ON THE STREET, AT YOUR HOME, IN JAIL, AT WORK, OR WHILE DRIVING:

- **DO NOT ANSWER ANY QUESTIONS ABOUT YOUR IMMIGRATION STATUS**
- **DO NOT SIGN ANYTHING WITHOUT SPEAKING TO AN ATTORNEY FIRST**
- **NEVER PLEAD GUILTY TO ANY CRIMINAL CHARGE WITHOUT TALKING TO AN ATTORNEY**

IF ICE COMES TO YOUR HOUSE:

- **DO NOT OPEN THE DOOR. Be aware:** ICE may lie to you about who they are.
- **TRY TO STAY CALM AND DO NOT LIE.** Just say "I do not want to answer any questions."
- If ICE enters your home, make sure to state that you do not consent to a search of your person or your belongings.

IF ICE STOPS YOU IN A STREET OR PUBLIC PLACE:

- **STAY CALM. DO NOT RUN.** If possible, take photos, video, and/or notes of the encounter.
- Ask if you are being arrested or detained, but do not answer any of their questions. If they say you are not being arrested, ask if you are free to leave.
- **DO NOT CARRY ANY DOCUMENTS FROM THE COUNTRY WHERE YOU WERE BORN.** Carry a local form of picture ID instead - a driver's license, school or work ID. Try to carry proof of your presence in the U.S. before February 2014 such as a phone, gas, or electric bill.

IF ICE ARRESTS YOU OR DETAINS YOU OR A LOVED ONE:

State that you want to speak to an attorney.

2027 Legislative Session

As Montana heads toward the 2027 legislative session, residents should pay close attention to proposals that could significantly reshape the state's tax system and shift more financial burden onto working families. At a recent event in Helena hosted by the Mountain States Policy Center, Gov. Greg Gianforte announced that one of his top priorities for the upcoming session will be pushing Montana toward a flat income tax. A statewide sales tax has also been his pet project since before he was elected governor.

Policy analysts warn that lower state revenue could eventually mean pressure to cut services such as public education, health programs, and community support systems. These are services that many rural and working-class Montanans rely on.

As lawmakers prepare for 2027, the debate will center on a key question:

Who benefits from Montana's tax policy changes and who pays the price?

For residents concerned about affordability and community services, the coming legislative session may shape the state's economic landscape for years to come. Staying informed and engaged will be essential. Keep reading for flat and sales tax information and what you can do. Knowledge is power!

The Mountain States Policy Center is often compared to the Heritage Foundation, but with a more regional focus. It is backed and run by ultra wealthy donors and promotes policies under the motto "Free Markets First." That priority places billionaire profit above the needs of families, communities, and even the state itself. When evaluating its policy recommendations, it's worth asking yourself the question above.

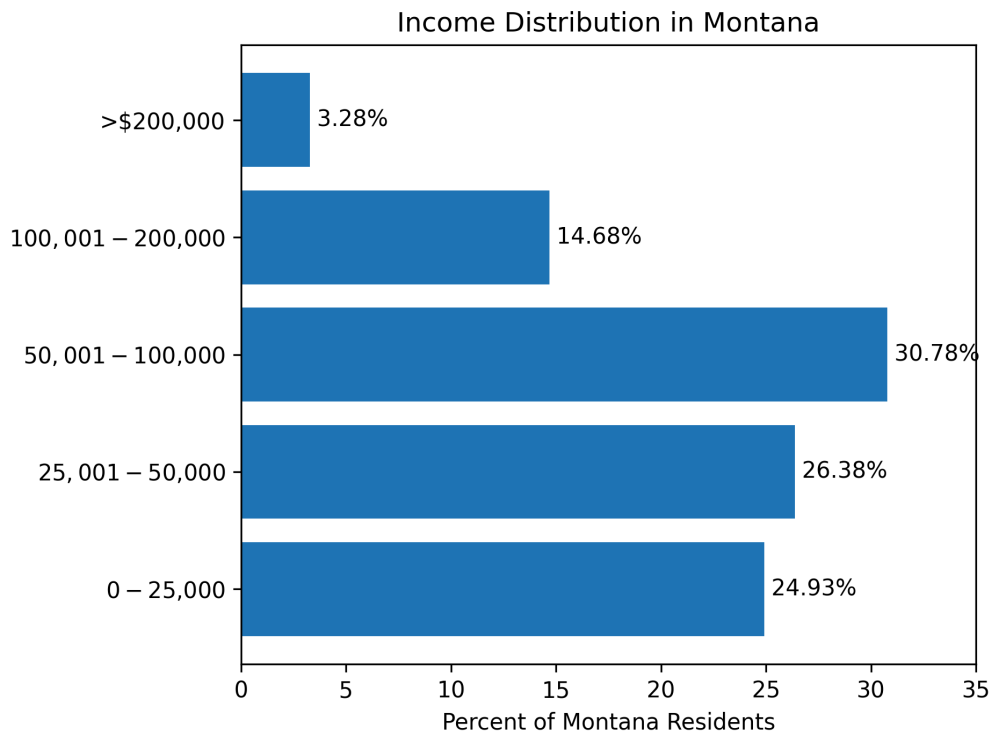


Tax Policy

Tax policies often touted as “fair” turn out to be regressive, either in practice or in effect. This means they impact those lower and middle income earners more. For instance, the **flat income tax** proposed by Gov. Gianforte will significantly decrease the tax burden for high income earners without reducing the tax burden for low income Montanans. Additionally, high-income earners often do not have to report a significant portion of their investment earnings as income. With no plan to replace the revenue lost by the tax decrease on high-income earners, you will feel the squeeze in one way or another, but the billionaire governor will not.

Lost tax revenue with no plan to make up that difference means more expensive or lost goods & services to you, which hurts the poor and middle class the most and in particular, hurts Montana children.



- Nearly 25% of Montanans earn less than \$25,000

- Only 3.28% of Montanans earn more than \$200,000

A **sales tax** seems fair, “you buy more, you pay more,” until you consider that a sales tax increases the burden of taxes on the poor and middle income earners because it costs more to buy the necessities of life, leaving less for savings, education, emergencies, retirement, etc. There is nothing fair about people at the bottom shouldering any additional tax burdens. A sales tax hits families with lower & moderate incomes the hardest.

Regular Montana families spend a larger share of their incomes on basic goods and services that would be taxed, like car tires, winter coats, and school supplies.

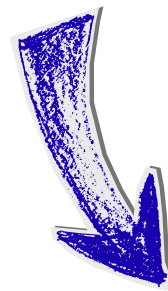

2026 Primaries: June 2nd

The decision by Greg Gianforte’s administration to stop issuing protest permits on weekends at the Montana State Capitol should concern every Montanan who values the First Amendment to the United States Constitution.

Montanans are noticing a pattern. Too often, decisions that affect the public are made behind closed doors by elitists, with little notice and no meaningful input from the people they affect. Policies are changed quietly while ordinary residents are left out of the conversation. That is not how representative government is supposed to work.

The Capitol is often called the people’s house because it belongs to the public, not to any governor. Limiting protests to weekdays effectively shuts out thousands of working Montanans or those who don’t reside in the Queen City and can only participate on weekends and makes it harder for everyday people to take part in civic life.

It is also troubling that the policy appears to have changed without transparency or public input. When the Montana Department of Administration makes decisions affecting access to the Capitol grounds, Montanans deserve clear notice and accountability.

What Montanans can do

If Montanans believe the Capitol should remain open for public protest on weekends, they should make their voices impossible to ignore. Call and email the governor’s office and the Department of Administration. Ask for the written policy, the legal justification, and the communications that led to the change.

And most importantly, write letters.

Letters to state officials become part of the official record and must be preserved under Montana’s constitutional transparency laws, otherwise known as the Montana Sunshine Laws. Those records can later be requested by the public, creating accountability that phone calls and emails often do not.

Organize with friends, neighbors, and community groups. Send letters demanding answers. Then follow up with public records requests asking for all correspondence and documents related to your letters and to the policy itself. Every letter forces the issue into the public record.

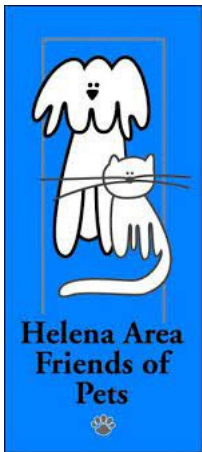
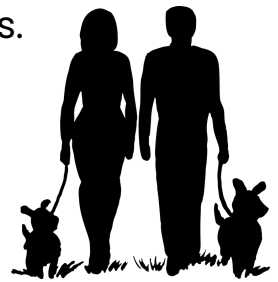
Pets

Many local families struggle to afford food, supplies, and medical care for their pets especially with the inevitable economic recession we are facing. When pets are surrendered due to financial hardship, it affects not only the animals but also the well-being of the family and our community. Animal Control, the Lewis & Clark Humane Society, and smaller local rescues can become overwhelmed with surrendered pets.

You can help!

Donate pet food at the collection bins near the doors at Safeway or Food Share. The Humane Society also has a large outdoor bin for feral cat food donations. If you're having trouble affording pet food, contact the **Lewis & Clark Humane Society** for referrals to assistance. You can also anonymously write down a request at a Free Little Pantry location. Most requests are rapidly fulfilled. Low-income households can reach out to the **Helena Area Friends of Pets** for financial help with spaying, neutering, and vaccinating their pets.
