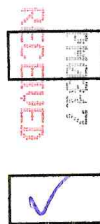

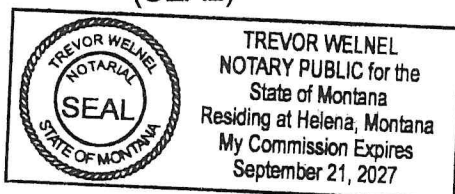

CAMPAIGN FINANCE COMPLAINT

This Complaint is filed by Robyn Mohs 10/10/2024

This Complaint is filed against John Repke, candidate for Montana State Auditor, and the Repke for Montana campaign committee. The Address of both appears to be PO Box 1613, Whitefish, MT 59937.

Repke has begun to run/promote paid video advertising on at least two social media platforms, as indicated in Exh. 1. This is a clear violation of MCA 13-35-225 (5) (6) which requires proper attribution, including party affiliation, on campaign distributed materials and advertising.

RELIEF REQUESTED:

- That Repke/the Repke for Montana Committee be determined to have violated Montana's campaign finance laws in that their social media advertisements/promotions fail to include Repke's party affiliation disclosure disclaimers required by Montana law.
- That these campaign disclosure violations be found to have been continual and ongoing as the proper legal disclosures have been omitted since the creation of the ads.
- That Repke be immediately directed to take down his Social Media Ads
- That a civil penalty be assessed against Repke/the Repke for Montana Campaign.

Since it appears this is a pattern for this candidate, and that he has been a candidate for office multiple times and should not have any excuses for this recurring issue, I am asking that my complaint be taken seriously in the interest of the voters and transparency laws set in place by our Montana Legislature for the people of Montana.

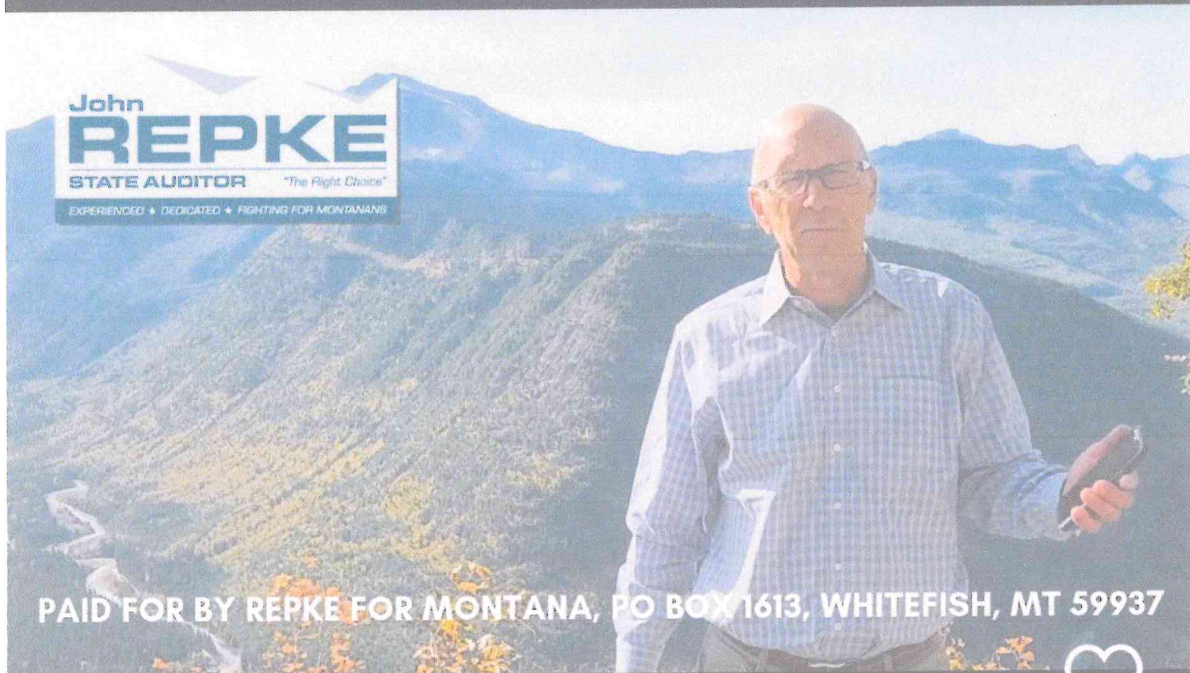

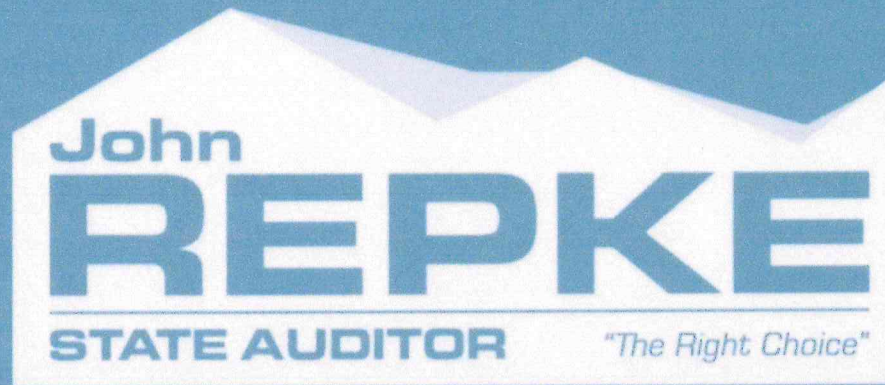

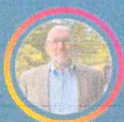
