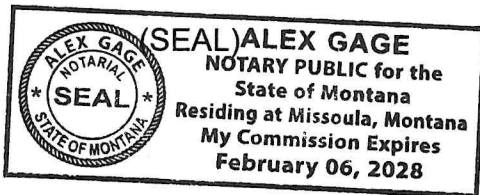

2. As a statewide candidate for office, Mr. Mullen shall file with the Commissioner of Political Practices periodic electronic reports of contributions and expenditures made by or on the behalf of the candidate. See Section 13-37-225(1)(a), MCA.
3. Mr. Mullen must file reports on the 20th day of June in the year of an election in which the candidate participates. See Section 13-37-226(1)(b), MCA.
4. Mr. Mullen is participating in the November 2024 election.
5. The deadline for Mr. Mullen to file the periodic contribution and expenditure report was June 20, 2024.
6. Mr. Mullen failed to file this report. Whatsoever.
7. Therefore, as a candidate for Secretary of State, Mr. Mullen has violated Montana law.
