In violation of MCA 13-37-226 and 13-37-225, Bozeman Tenants United has not filed as an incidental committee opposed to the Bozeman Water Adequacy ballot initiative that is on the Nov. 2025 ballot, and has not reported expenditures including of the forum hosted on 9/24/25. While Bozeman Tenants United did not violate anything in regards to the Mayoral and commission races because all candidates were invited to participate, the committee expended resources to oppose the Bozeman Water Adequacy ballot initiative. Substantial time of the forum - one of the four questions to andidates was in regards to their "Stance on harmful water Adequacy" initiative, so the expenditures on the food, venue rental, and printing of materials given to attendees (included) should be reported as expenditures opposing the Water Adequacy ballot initiative. The committee also has paid staff who are spending time advocating against the Water Adequacy ballot initiative.

Bozeman candidates sound off on tenant organizing, housing ballot initiative at first campaign forum

City commission and mayoral candidates answered questions about tenants rights and housing Wednesday night at the first public forum of the November city election

cycle.

During the forum hosted by Bozeman Tenants United at the Bozeman Event Space, attendees were given red and green sheets of paper and encouraged to wave them high in the air if they agreed or disagreed with what candidates were saying.

Red papers waved when some candidates said they didn't support a program to provide lawyers to people facing evictions, a program the tenants union has championed. A mix of red and green came up when candidates answered a question about the Water Adequacy for Residential Development ballot initiative.

The initiative, called WARD, would require most residential developers to either bring water rights into the city for their projects, or rent or sell one-third of their units at below market rate levels if they want to pay cash-in-lieu of water rights instead.

The controversial idea is championed partially by Bozeman lawyer John Meyer, who is running for mayor, and has drawn criticism from wide-ranging interest groups. Those include the Bozeman Chamber of Commerce, building and Realtors groups and the tenants union itself, which voted unanimously not to support the idea in May when organizers were gathering signatures to put the question on the ballot.

Commissioner Douglas Fischer, who is running for mayor, Commissioner Emma Bode, who is running to retain her seat, and commissioner candidates Emily Talago, Eli Anselmi and Trevor Nameniuk and mayoral candidate Brendan O'Connor said they did not support the policy.

"The bottom line is the mandate is too steep," O'Connor said. "Most builders will just not build at all, and that does not benefit anyone, and it doesn't create affordable housing. I think we would be better served by creating incentives for developers to build affordable housing."

Fischer and some other candidates pointed to concerns that the initiative could lead to sprawl, increase housing prices and shut down new housing development in the city.

"We need effective leadership that on January 13 has a package in front of the new City Commission focused on results. That ... doubles down on water security." Fischer said. "Let's expand our toolbox instead of reducing it to one rigid mandate."

A third-party consultant hired by the city presented an analysis to commissioners Tuesday that found the policy would make building unfeasible in the city. Nameniuk said he sees the policy as a building moratorium.

"When you use that emotional appeal and stuff that isn't true to sell something else, that just doesn't really sit right with me," Nameniuk said. "So there's that issue. I'm, of course, all for protecting water. We have to do so, again, in thoughtful and responsible ways."

Meyer spoke in favor of it, Commission candidate Roger Blank said he was still undecided, and Commission candidate Alison Sweeney said it doesn't matter how she feels because it is up to the voters.

"What we have now is unsustainable. It's garbage, and the city is fear-mongering, saying we have to keep the status quo," Meyer said.

Candidates also answered a question about whether they would implement the tenants right to counsel program, which the current City Commission has thrown its support behind. Several candidates said they support the program, but that the city should be creative in finding a funding source so property tax burdens aren't increased.

"We also have to be real about budget constraints and revenue constraints too. But

that doesn't mean that we say, 'Oh, well, like there's nothing we can do here'," Talago said.

Blank said he does not support the idea.

"This idea is a luxury the city could afford," he said. "Philosophically, it's not government's job to take care of me. It's government's job to create an economic environment where I can take care of myself."

The tenants union also asked candidates their thoughts on recent unionizing efforts from mobile home park residents and gave them a chance to make an appeal to voters. Anselmi and Blank both noted they didn't expect to win many votes in the room.

Anselmi said he supports a limited government.

"The primary functions of the city has to do with, first and foremost, public safety; second, city budget, infrastructure. Those are really the primary functions of the city. That's what we need to be worrying about," Anselmi said.

Sweeney used some of her time to say she wants the city to explore more ways to create non-market-rate housing.

"I'm going to be honest with you, no City Commission is ever going to be able to correct the housing market, but we can build housing outside of that market, and we need to do it yesterday," she said.

Bode said she supports policies that make it easier to build affordable housing.

"My housing platform centers on passing a pro-housing building code that makes it easier to build affordable housing, establishing a robust transitional housing program to move people from the streets into stable housing, fortifying tenants rights and passing a right-to-counsel program to keep people in homes they can afford and exploring ways to de-commodify housing," Bode said.
