#### HVAC Replacement Project: Estimated Cost \$2,250,000

#### PART 1: POLITICAL COMMITTEES

#### **Political Committee**

"Political committee" means a combination of two or more individuals, or a "person other than an individual" (a corporation, association, firm, partnership, cooperative, committee, club, union, or other organization) who receives a contribution or makes an expenditure:

- To support or oppose a candidate, or a committee organized to support or oppose a candidate or petition for nomination;
- b) To support or oppose a ballot issue, or committee organized to support or oppose a ballet issue; or
- c) To prepare or disseminate an election communication, an electioneering communication, or an independent expenditure.

Political committees include ballot issue committees, incidental committees, independent committees and political party committees. A political committee is formed when a combination of two or more individuals or a person other than an individual makes an election communication, an electioneering communication, or an independent expenditure of \$250 or less of reportable election activity.

## Naming your Committee

Political committees must name and identify themselves in a way that specifically identifies their economic, or special interest, or employer. For details, see 13-37-210, MCA and the interpretation and enforcement opinion on our website.

#### **Types of Committees**

## Ballot issue committee

As the name implies, a ballot issue committee is organized to support or oppose a particular ballot issue, including "initiatives, referenda, proposed constitutional amendments, recall questions, school levy questions, bond issue questions, or a ballot question," 13-1-101(6) and (7), MCA.

A statewide issue becomes a ballot issue "upon preparation and transmission by the Secretary of State of the form of the petition or referral to the person who submitted the proposed issue," 13-1-101(6)(b), MCA. A local issue becomes a local ballot issue "upon certification by the proper official that the legal procedure necessary for its qualification and placement on the ballot has been completed", 13-1-101(6)(b), MCA.

Both statewide and local ballot issue committees must file a Form C-2, Statement of Organization, with the COPP within five days after the issue becomes a ballot issue, 13-37-201, MCA. A ballot issue committee's initial Form C-6, Political Committee Finance Report must include all contributions received and expenditures made by the committee since its date of foundation to qualify the issue for the ballot, 13-37-226, MCA. See Footnote 1 on page 8 for special district exceptions.

As with other committees, a ballot issue committee must keep accurate records of contributions and expenditures, must comply with campaign finance and practices laws, and must file the appropriate finance report forms and disclosures.

#### Independent committee

An independent committee means a political committee organized for the primary purpose of receiving contributions and making expenditures that are not controlled either directly or indirectly by a candidate and that does not coordinate with a candidate in conjunction with making expenditures except as within the contribution limits set in 13-37-216(1), MCA, and 13-1-101(23), MCA.

An independent committee is commonplace in campaign activities, both nationally and in the states. Frequently the committee is composed of employees of a common employer or members a particular profession or trade. These individuals contribute to their own committee for the purpose of supporting or opposing candidates and/or issues that the committee agrees on. Most independent committees participate in elections year after year.

#### Political party committee

A political party committee is "a political committee formed by a political party organization and includes all county and city central committees", 13-1-101(31), MCA. In turn, a "political party organization" "means a political organization that was represented on the official ballot in either of the two most recent statewide general elections; or has met the petition requirements, as provided in Title 13, chapter 10, part 5", 13-1-101(32)(a) and (b). For the 2018 election cycle, the political party organizations that have qualified to be political party committees are the Republican, Libertarian, and Democratic Party committees.

These committees support candidates of their own party, oppose candidates of opposition parties, and support or oppose selected issues usually based on party platforms.

Political party committees are similar to independent committees in terms of their wideranging participation in campaigns; however, they are different in how they form and in their associational functions, which go beyond simply participating in elections.

Limitations on contributions from political party committees do not include a coordinated expenditure made solely by a political party committee for personal services by paid staff that benefits the associational interest of the political party as well as a candidate, ARM 44.11.401. The value of the paid personal services is reportable by the political party committee and the candidate benefitting on their campaign finance reports. See example addendum in Part 5 of this manual, to submit the addendum please email the spreadsheet to CPPHelp@mt.gov, which will then become searchable through the hard copy search system.

Example: the Montana Democratic Party hires interns to do literature drops for several candidates for the legislature. The Montana Democratic Party will have to report the amount of the paid personal services and report the value received by each candidate that benefitted from those services. The candidate will have to report the value as an in-kind contribution from the Montana Democratic Party as well. The personal services contributions do not count towards the aggregate political party contribution limit to a candidate.

Another important distinction of a political party committee is that it "may not contribute to a judicial candidate," 13-35-231, MCA.

#### Incidental committee

An incidental committee is a political committee that is not specifically organized or operated for the primary purpose of supporting or opposing candidates or ballot issues but may incidentally become a political committee by receiving a contribution or making an expenditure, 13-1-101(22), MCA.

Example: A local Ace Hardware has an interest in a ballot issue that could impact the owner's ability to conduct business. The primary purpose of Ace Hardware is to sell home improvement supplies, not support or oppose ballot issues. Ace Hardware writes a check to the organized ballot issue committee that is opposing the issue on the ballot for \$1,000. In addition, the store owner decides that he will make some signs to put in his store window. By making these two expenditures, Ace Hardware incidentally became involved in a local election making it qualify as an incidental committee. Ace Hardware is required to register as a political committee and report the expenditures made to oppose the ballot issue.

Primary Purpose Identifying the primary purpose of a political committee helps both the officers of the committee and the COPP classify the committee appropriately. The term "primary purpose" refers to the major principal, important goal, or the reason for existence for a committee, ARM 44.11.203. The criteria that should be considered when determining the primary purpose of a committee is as follows:

- allocation and source of budget;
- allocation of staff or member's activity, both during an election and otherwise:
- the statement of purpose, articles of incorporation, bylaws, or goals;
- reportable election activity;
- the history of the committee and the numbers of elections in which it has participated or registered;
- receipt of contributions in response to an appeal or that are designated for a specified candidate, ballot issue, petition, or reportable election activity;
- the number or cost of reportable election expenditures made;
- coordination with any candidates or other political committees;
- ordinary business actually conducted;
- if a corporation, whether it was created and maintained as provided by law;
- the date of founding, incorporation, or organization.

A committee may submit any information it wishes the COPP to consider in classifying the committee. The organization will be notified of the COPP's classification. If the organization disagrees with the COPP's classification, the organization can submit additional information and request to be reclassified pursuant to ARM 44.11.204.

## School advocates work to gather community support for bond and levy

A group of local residents has come together to help garner support for the Glendive Public School district's proposed bond and building reserve levy that will be presented to voters later this year. Defining the schools as the heart of the community, they are hoping to make people aware of the potential ramifications should the bond and levy fail to pass.

This effort is entirely citizen-driven, independent from the Glendive Public Schools District.

The group currently consisting of local residents Jamie McMillan, Sarah Thorson and Kayla Rivas, but they are hoping to grow by connecting directly with individual community members to discuss issues in the schools and drum up the support needed to address those issues. In particular, they are hoping to tackle the issues that they believe have been the primary factors in past bond and levy attempts failing to garner the support needed.

"Our mission is to unite our community and eliminate the 'us'versus 'them' mentality that has hindered the success of past school bonds and levies. We firmly believe that passing the school bond and levy is not just about improving facilities and education; it is about fostering a thriving, interconnected community that benefits us all,"the group said in a statement.

McMillan, who has been a regular fixture at school board meetings since the previous bond and levy failure in May, has been particularly interested in addressing these issues for some time.

"Our mission is to unite our community and eliminate the 'us' versus 'them' mentality that has hindered the success of past school bonds and levies. We firmly believe that passing the school bond and levy is not just about improving facilities and education; it is about fostering a thriving, interconnected community that benefits us all."

She grew up in Glendive though lived away for some time, including during previous bond attempts. However, she remained engaged during those previous periods and saw the community discourse that occurred around them.

Now that she has been back in Glendive for some time and been present for the recent bond attempts, she said she is excited to begin digging at the root of the issues as she and the other advocates believe ensuring the success of the schools will ultimately ensure the success of the community.

"From a kind of outsider looking in, it feels like people have picked a team and they want to stick to their allegiance. At this point, I feel like nothing that happened in the past matters. It doesn't matter how we got here, what happened, what side you were on. At this point, I think that everybody has to be on the same team: the community," she said. about:blank

The central part of this advocacy campaign is based on having open and collaborative dialogues with individual community members, hopefully resulting in a large-scale support base. These conversation will include attempts to demonstrate how a healthy, well-supported school system can positively impact nearly every facet of the community, from boosting economic development to overall pride in a community.

Thorson pointed out that a lack of communication and lack of participation were noticeably missing during the previous bond attempt. By reaching out to the community on an individual basis, the group is hoping to increase overall engagement.

"The biggest thing in our plans is building a community within the community and having a lot of personal conversations," Thorson said. "We just feel there weren't a lot of conversations being had in the community, among friends or just out and about. So our aim is really just to reach a lot of people individually and have those conversations. Not everyone we reach may necessarily agree, but it's important to have those conversations."

To better help facilitate this community engagement, the group has created a new Facebook page, GPS Advocates, where anyone is welcome to message or interact. The high school bond and levy election is set for Aug. 8. Mail ballot will be sent out in mid-July.



## CONSTITUENT ADVOCACY HAD IMPACT ON OUTCOME OF RECENT SCHOOL **ELECTION**

Constituent advocacy credited for outcome of Glendive school election

Voter turn-out in the recent school bond and levy election was up significantly over the first election earlier this year and a local advocacy group is getting the credit not just for the participation, but the outcome as well. The group, GPS Advocates, formed following the the first election in May after the bond and levy issues failed with the aim of engaging voters on an individual level in an attempt to improve turn out for the next election on Aug. 8, especially in support of the bond and levy.

For the past several months, the Advocates have been performing that outreach and appear to have come out successful. Voter turnout was higher in this month's election, with voter participation over 66% with a total of 3,090 votes being counted.

The previous election on May 2, by contrast, had a participation rate of just a little over 51% with a total of 2,378 votes being counted. From one election to the next, that amounts to a roughly 30% increase in total votes counted on Aug. 8.

Last week, the bond receiving about 61% of the vote in favor and the levy receiving roughly 63% of the vote.

"I think it's really exciting and I think it's really a testament to where Glendive is as a community right now," said Jamie McMillan, one of the Advocates' original members. "We were really able to achieve some quality engagement and we're getting a lot of good feedback."

While voters of all demographics were engaged by the advocates, McMillan noted that they saw good engagement from younger voters. She explained that those the advocates engaged with seemed to be very responsive to the strategy of one-on-one, more personal conversations, with many of those they spoke with seemingly leaving with more of an understanding of the issues the Advocates were trying to highlight. Many young voters registered to vote for the first time, McMillan said.

That influence can be seen in the number of voters that registered in the time leading up to the election. According to information provided by Dawson County Clerk and Recorder Shirley Kreiman, there were 68 voters who registered between July 1 and the August election, but only 11 registered from April 1 to the May 2 election. There were also overall more ballots issued for the August election, with a net gain of 20 registrations bringing the total voter count to 4,627 compared to May's 4,607.

With that much more participation, McMillan said she was happy but ultimately unsurprised to see both the bond and levy pass by significant margins, saying that the results reflect the community effort that was put into the election.

"I think we tried really hard that we had the messaging to reach as many people as we could. We wanted our message to be heard that this was really vital to our community and everybody who lives here, not just our school district and not just our kids. I believe there are a lot of people who live in Glendive who believe in Glendive who want really good things for Glendive, and I think that message was received," she said.

Some people though were rather surprised by the results, and not just in the passing but the wide margin as well. These people include Glendive Unified School Board Chairman Mike Ziegler, who said his personal feelings leading up to the vote were that the decision was going to come down to a much closer decision. However, seeing the final results has left him feeling grateful for both the community's support and the especially the Advocates' efforts.

"I didn't imagine it would be that big of a landslide. We always played like we were behind in the game and doing everything we could to get everything to get info out to the public, just doing everything we could to exhaustion, us and the Advocates, who I definitely think were the 'X' factor in this," Ziegler said. "It was a total community effort, which was just amazing."

Looking forward, McMillan said she would like to see this community engagement continue. The GUSB will likely begin crafting another bond for the elementary district in the near future, something that was previously discussed in the lead up to the high school bond. For that to stand any chance though, community support will once again be a vital asset.

"I think what the GPS Advocates started for the high school bond and levy is just the beginning of what is going to have to happen for the next bond," McMillan said.

## PART 1: POLITICAL COMMITTEES

#### **Political Committee**

"Political committee" means a combination of two or more individuals, or a "person other than an individual" (a corporation, association, firm, partnership, cooperative, committee, club, union, or other organization) who receives a contribution or makes an expenditure:

- To support or oppose a candidate, or a committee organized to support or oppose a candidate or petition for nomination;
- b) To support or oppose a ballot issue, or committee organized to support or oppose a ballet issue; or
- To prepare or disseminate an election communication, an electioneering communication, or an independent expenditure.

Political committees include ballot issue committees, incidental committees, independent committees and political party committees. A political committee is formed when a combination of two or more individuals or a person other than an individual makes an election communication, an electioneering communication, or an independent expenditure of \$250 or less of reportable election activity.

#### Naming your Committee

Political committees must name and identify themselves in a way that specifically identifies their economic, or special interest, or employer. For details, see 13-37-210, MCA and the interpretation and enforcement opinion on our website.

## **Types of Committees**

## Ballot issue committee

As the name implies, a ballot issue committee is organized to support or oppose a particular ballot issue, including "initiatives, referenda, proposed constitutional amendments, recall questions, school levy questions, bond issue questions, or a ballot question," 13-1-101(6) and (7), MCA.

A statewide issue becomes a ballot issue "upon preparation and transmission by the Secretary of State of the form of the petition or referral to the person who submitted the proposed issue," 13-1-101(6)(b), MCA. A local issue becomes a local ballot issue "upon certification by the proper official that the legal procedure necessary for its qualification and placement on the ballot has been completed", 13-1-101(6)(b), MCA.

Both statewide and local ballot issue committees must file a Form C-2, Statement of Organization, with the COPP within five days after the issue becomes a ballot issue, 13-37-201, MCA. A ballot issue committee's initial Form C-6, Political Committee Finance Report must include all contributions received and expenditures made by the committee since its date of foundation to qualify the issue for the ballot, 13-37-226, MCA. See Footnote 1 on page 8 for special district exceptions.

As with other committees, a ballot issue committee must keep accurate records of contributions and expenditures, must comply with campaign finance and practices laws, and must file the appropriate finance report forms and disclosures.

## Independent committee

An independent committee means a political committee organized for the primary purpose of receiving contributions and making expenditures that are not controlled either directly or indirectly by a candidate and that does not coordinate with a candidate in conjunction with making expenditures except as within the contribution limits set in 13-37-216(1), MCA, and 13-1-101(23), MCA.

An independent committee is commonplace in campaign activities, both nationally and in the states. Frequently the committee is composed of employees of a common employer or members a particular profession or trade. These individuals contribute to their own committee for the purpose of supporting or opposing candidates and/or issues that the committee agrees on. Most independent committees participate in elections year after year.

## Political party committee

A political party committee is "a political committee formed by a political party organization and includes all county and city central committees", 13-1-101(31), MCA. In turn, a "political party organization" "means a political organization that was represented on the official ballot in either of the two most recent statewide general elections; or has met the petition requirements, as provided in Title 13, chapter 10, part 5", 13-1-101(32)(a) and (b). For the 2018 election cycle, the political party organizations that have qualified to be political party committees are the Republican, Libertarian, and Democratic Party committees.

These committees support candidates of their own party, oppose candidates of opposition parties, and support or oppose selected issues usually based on party platforms.

Political party committees are similar to independent committees in terms of their wideranging participation in campaigns; however, they are different in how they form and in their associational functions, which go beyond simply participating in elections.

Limitations on contributions from political party committees do not include a coordinated expenditure made solely by a political party committee for **personal services** by paid staff that benefits the associational interest of the political party as well as a candidate, ARM 44.11.401. The value of the paid personal services is reportable by the political party committee and the candidate benefitting on their campaign finance reports. See example addendum in Part 5 of this manual, to submit the addendum please email the spreadsheet to <u>CPPHelp@mt.gov</u>, which will then become searchable through the hard copy search system.

**Example:** the Montana Democratic Party hires interns to do literature drops for several candidates for the legislature. The Montana Democratic Party will have to report the amount of the paid personal services and report the value received by each candidate that benefitted from those services. The candidate will have to report the value as an in-kind contribution from the Montana Democratic Party as well. The personal services contributions do not count towards the aggregate political party contribution limit to a candidate.

Another important distinction of a political party committee is that it "may not contribute to a judicial candidate," 13-35-231, MCA.

#### Incidental committee

An incidental committee is a political committee that is not specifically organized or operated for the primary purpose of supporting or opposing candidates or ballot issues but may incidentally become a political committee by receiving a contribution or making an expenditure, 13-1-101(22), MCA.

Example: A local Ace Hardware has an interest in a ballot issue that could impact the owner's ability to conduct business. The primary purpose of Ace Hardware is to sell home improvement supplies, not support or oppose ballot issues. Ace Hardware writes a check to the organized ballot issue committee that is opposing the issue on the ballot for \$1,000. In addition, the store owner decides that he will make some signs to put in his store window. By making these two expenditures, Ace Hardware incidentally became involved in a local election making it qualify as an incidental committee. Ace Hardware is required to register as a political committee and report the expenditures made to oppose the ballot issue.

#### Primary Purpose

Identifying the primary purpose of a political committee helps both the officers of the committee and the COPP classify the committee appropriately. The term "primary purpose" refers to the major principal, important goal, or the reason for existence for a committee, ARM 44.11.203. The criteria that should be considered when determining the primary purpose of a committee is as follows:

- allocation and source of budget;
- allocation of staff or member's activity, both during an election and otherwise:
- the statement of purpose, articles of incorporation, bylaws, or goals;
- reportable election activity;
- the history of the committee and the numbers of elections in which it has participated or registered;
- receipt of contributions in response to an appeal or that are designated for a specified candidate, ballot issue, petition, or reportable election activity;
- the number or cost of reportable election expenditures made;
- coordination with any candidates or other political committees;
- ordinary business actually conducted;
- if a corporation, whether it was created and maintained as provided by law;
- the date of founding, incorporation, or organization.

A committee may submit any information it wishes the COPP to consider in classifying the committee. The organization will be notified of the COPP's classification. If the organization disagrees with the COPP's classification, the organization can submit additional information and request to be reclassified pursuant to ARM 44.11.204.



## PART 1: POLITICAL COMMITTEES

## Political Committee

"Political committee" means a combination of two or more individuals, or a "person other than an individual" (a corporation, association, firm, partnership, cooperative, committee, club, union, or other organization) who receives a contribution or makes an expenditure:

- To support or oppose a candidate, or a committee organized to support or oppose a candidate or petition for nomination;
- b) To support or oppose a ballot issue, or committee organized to support or oppose a ballet issue; or
- c) To prepare or disseminate an election communication, an electioneering communication, or an independent expenditure.

Political committees include ballot issue committees, incidental committees, independent committees and political party committees. A political committee is formed when a combination of two or more individuals or a person other than an individual makes an election communication, an electioneering communication, or an independent expenditure of \$250 or less of reportable election activity.

#### Naming your Committee

Political committees must name and identify themselves in a way that specifically identifies their economic, or special interest, or employer. For details, see 13-37-210, MCA and the interpretation and enforcement opinion on our website.

## **Types of Committees**

## Ballot issue committee

As the name implies, a ballot issue committee is organized to support or oppose a particular ballot issue, including "initiatives, referenda, proposed constitutional amendments, recall questions, school levy questions, bond issue questions, or a ballot question," 13-1-101(6) and (7), MCA.

A statewide issue becomes a ballot issue "upon preparation and transmission by the Secretary of State of the form of the petition or referral to the person who submitted the proposed issue," 13-1-101(6)(b), MCA. A local issue becomes a local ballot issue "upon certification by the proper official that the legal procedure necessary for its qualification and placement on the ballot has been completed", 13-1-101(6)(b), MCA.

Both statewide and local ballot issue committees must file a Form C-2, Statement of Organization, with the COPP within five days after the issue becomes a ballot issue, 13-37-201, MCA. A ballot issue committee's initial Form C-6, Political Committee Finance Report must include all contributions received and expenditures made by the committee since its date of foundation to qualify the issue for the ballot, 13-37-226, MCA. See Footnote 1 on page 8 for special district exceptions.

#### Independent committee

As with other committees, a ballot issue committee must keep accurate records of contributions and expenditures, must comply with campaign finance and practices laws, and must file the appropriate finance report forms and disclosures.

An independent committee means a political committee organized for the primary purpose of receiving contributions and making expenditures that are not controlled either directly or indirectly by a candidate and that does not coordinate with a candidate in conjunction with making expenditures except as within the contribution limits set in 13-37-216(1), MCA, and 13-1-101(23), MCA.

An independent committee is commonplace in campaign activities, both nationally and in the states. Frequently the committee is composed of employees of a common employer or members a particular profession or trade. These individuals contribute to their own committee for the purpose of supporting or opposing candidates and/or issues that the committee agrees on. Most independent committees participate in elections year after year.

#### Political party committee

A political party committee is "a political committee formed by a political party organization and includes all county and city central committees", 13-1-101(31), MCA. In turn, a "political party organization" "means a political organization that was represented on the official ballot in either of the two most recent statewide general elections; or has met the petition requirements, as provided in Title 13, chapter 10, part 5", 13-1-101(32)(a) and (b). For the 2018 election cycle, the political party organizations that have qualified to be political party committees are the Republican, Libertarian, and Democratic Party committees.

These committees support candidates of their own party, oppose candidates of opposition parties, and support or oppose selected issues usually based on party platforms.

Political party committees are similar to independent committees in terms of their wideranging participation in campaigns; however, they are different in how they form and in their associational functions, which go beyond simply participating in elections.

Limitations on contributions from political party committees do not include a coordinated expenditure made solely by a political party committee for personal services by paid staff that benefits the associational interest of the political party as well as a candidate, ARM 44.11.401. The value of the paid personal services is reportable by the political party committee and the candidate benefitting on their campaign finance reports. **Example:** the Montana Democratic Party hires interns to do literature drops for several candidates for the legislature. The Montana Democratic Party will have to report the amount of the paid personal services and report the value received by each candidate that benefitted from those services. The candidate will have to report the value as an in-kind contribution from the Montana Democratic Party as well. The personal services contributions do not count towards the aggregate political party contribution limit to a candidate.

Another important distinction of a political party committee is that it "may not contribute to a judicial candidate," 13-35-231, MCA.

#### Incidental committee

An incidental committee is a political committee that is not specifically organized or operated for the primary purpose of supporting or opposing candidates or ballot issues but may incidentally become a political committee by receiving a contribution or making an expenditure, 13-1-101(22), MCA.

Example: A local Ace Hardware has an interest in a ballot issue that could impact the owner's ability to conduct business. The primary purpose of Ace Hardware is to sell home improvement supplies, not support or oppose ballot issues. Ace Hardware writes a check to the organized ballot issue committee that is opposing the issue on the ballot for \$1,000. In addition, the store owner decides that he will make some signs to put in his store window. By making these two expenditures, Ace Hardware incidentally became involved in a local election making it qualify as an incidental committee. Ace Hardware is required to register as a political committee and report the expenditures made to oppose the ballot issue.

#### Primary Purpose

Identifying the primary purpose of a political committee helps both the officers of the committee and the COPP classify the committee appropriately. The term "primary purpose" refers to the major principal, important goal, or the reason for existence for a committee, ARM 44.11.203. The criteria that should be considered when determining the primary purpose of a committee is as follows:

- allocation and source of budget;
- allocation of staff or member's activity, both during an election and otherwise;
- the statement of purpose, articles of incorporation, bylaws, or goals;
- reportable election activity;
- the history of the committee and the numbers of elections in which it has participated or registered;
- receipt of contributions in response to an appeal or that are designated for a specified candidate, ballot issue, petition, or reportable election activity;
- the number or cost of reportable election expenditures made;
- coordination with any candidates or other political committees;
- ordinary business actually conducted;
- if a corporation, whether it was created and maintained as provided by law;
- the date of founding, incorporation, or organization.

A committee may submit any information it wishes the COPP to consider in classifying the committee. The organization will be notified of the COPP's classification. If the organization disagrees with the COPP's classification, the organization can submit additional information and request to be reclassified pursuant to ARM 44.11.204.
