### Complaint #1:

Daniel Carlino, a candidate for Ward 3 Missoula City Council, sent five separate text messages to an undetermined number of voters, between August 16, 2025 and August 26, 2025. These are included with this complaint. He claims these were sent without his knowledge by Maple Bridge Strategies who he had contracted to work on his campaign. These texts were illegal and Mr. Carlino's campaign potentially financially benefited from them.

- 1. These texts were sent without attribution. No "Paid for by..." was included on any of the texts so voters have no real idea who paid for them. This is a violation of Montana campaign finance laws.
- 2. Mr. Carlino didn't file a C-7 to note the expenditures of these texts in a timely manner (48 hours) as we are within 30 days of a primary election. This is a violation of Montana campaign finance laws.
- 3. Mr. Carlino didn't report any in-kind contributions to cover the costs of the texts. This is a violation of Montana campaign finance laws.
- 4. These texts were written in first person ("I'm Daniel Carlino") and provide specific links to Mr. Carlino's Act Blue fundraising page. These links seem to be specific forms in Act Blue as noted by the urls below and should be easily traceable. All of these link to pages that have this disclaimer: Paid for by Carlino for Missoula 729 S. 2nd Street W. Street Missoula, MT 59801

If they were sent by an organization or PAC on behalf of Mr. Carlino, there is no financial record of this. This amounts to coordination, is a violation of Montana campaign finance laws and calls into question the legality of any donations received from these texts.

These texts began appearing August 21 and were sent approximately every other day for five to seven days. If Mr. Carlino didn't approve them, why didn't he ask Maple Bridge Strategies to stop sending them after the first one? Why didn't he disavow them right away instead of waiting two weeks to address these texts and only after an op ed appeared in the Missoulian calling them into question.

Most importantly, did Mr. Carlino's campaign benefit financially from these text messages that were illegal? Again, the links are traceable as are the donations received through them. Does he plan on keeping this money?

### Complaint #2

Daniel Carlino's campaign posted illegal flyers on at least 25 power/light poles on Labor Day weekend. Pictures included in this complaint. The city of Missoula's code compliance team had to remove them after being notified.










And on that topic of campaign financing...Mr. Carlino to date has not filed expense reports for these texts, nor is there either an acknowledgment by his campaign for funding the texts, nor a disclaimer...all of which amount to campaign finance violations under Montana law.

Another candidate, Lucas Moody, who is running in Ward 1 has sponsored posters which state "Your Current City Council, Takes Money from PACs - Legally Distinct from Corruption". Another strong assertion that is a lie. No one in these races has taken money from a Political Action Committee - a "PAC".

Blatantly spreading these untruths is reflective of character and governing style. Missoula deserves honesty and transparency.

The undersigned have endorsed Jennifer Savage for Ward 3 and Betsy Craske for Ward 1. Their races are impacted by these lies. We call on the Democratic Socialist candidates to campaign truthfully and with integrity. After all what is the point of winning office if the candidate uses a sham to win?

Email Print Copy article link Aseries of text messages recently sent to voters from a Missoula City Council candidate contained inaccurate information, but that candidate told the Missoulian the messages were sent without his permission.

Ward 3 Councilor Daniel Carlino said he was working with a consultant on distributing campaign text messages, but the messages were sent to voters without his review and contained false information about political action committees.

The text messages sparked a **letter to the editor** from several current councilors and candidates, including incumbent Councilor Jennifer Savage who moved into Carlino's district this summer, claiming Carlino's text campaign was spreading "lies."

"It's really disappointing and harming my campaign that someone did that," Carlino told the Missoulian in a text message. "I didn't send a text to anyone that said any of what they're claiming. ... I don't endorse it."

The messages, which were distributed by DC-based consultant Maple Bridge Strategies, claimed that "corporate PACs and right-wing interests are targeting" Carlino and his city council seat, according to texts reviewed by the Missoulian.

Other texts from the group said Carlino was being targeted by the "Israeli lobby," while others said "MAGA millionaires" were pouring money into the race.

None of the texts included information for who paid for the messages, which is required under Montana state law.

MapleBridge Strategies told the Missoulian in a Tuesday phone call that the messages were sent in error. Brandon Russell, the group's executive director, also sent an apology letter to Carlino over the incident.

"At MapleBridge we pride ourselves on careful coordination and respecting the integrity of our clients' campaigns. In this instance, that standard was not met," Russell wrote in the letter to Carlino. "The text should have gone through your review process before being sent out, and I recognize that skipping that step was both unprofessional and unfair to you and your campaign."

Carlino said he does not plan to work with MapleBridge Strategies moving forward and noted that he did not pay the group because of the error. Carlino also said he contacted the Montana Commissioner of Political Practices about the incident.

The Montana Commissioner for Political Practices, Christopher Gallus, told the Missoulian on Friday that no formal complaint has been received by his office. Generally, a complaint is required to initiate an investigation, Gallus said.

Campaign finance reports for the race showed Carlino spent \$1,201.20 on text messages to voters on Aug. 27. Carlino told the Missoulian that the expenditure was for a different organization.

After some of the factually incorrect text messages circulated around Missoula, several candidates for office penned a letter to the Missoulian and other news outlets to condemn the texts for spreading misinformation.

"It is a lie to broadcast these claims," the letter said. "In fact, all donations listed by all candidates in these races are from individuals. Corporate PACs and right-wing interests? Nope. And how and where is the "Israel lobby" targeting Mr. Carlino? Nowhere in the candidates' financial reports, nor in reality. For Mr. Carlino to text these claims goes directly to his integrity. These are low blows and not true."

The letter, published on Aug. 28, was signed by Savage, Missoula Mayor Andrea Davis, City Council President Amber Sherrill, incumbent councilors Mike Nugent, Stacie Anderson, and Gwen Jones.

Council candidates Chris Foster and Betsy Craske also signed the letter.

Savage said in a statement to the Missoulian that she still has unanswered questions about the text messages and said candidates should follow state campaign rules.

"Ultimately, it's up to Mr. Carlino to answer these questions and the Commissioner of Political Practices to weigh in on likely violations of campaign finance laws of which there appear to be many," Savage said. "In the meantime, I'm focused on running my campaign, clean

and transparent, because voters deserve that from their elected officials."

Savage is also employing mass text messages, according to campaign finance reports. Savage spent \$1,160.64 on text messages on Aug. 26 and \$726.44 on texts on Aug. 21.

The primary election for city council seats in Ward 2, Ward 3 and Ward 6, as well as a primary for the Missoula mayor race, is set for Sept. 9.
