Dave Fern, candidate for House District 5 in 2016 has violated ARM 44.11.502(7) by failing to report the purpose, subject matter and quantity of election materials and ARM 44.11.502(2) by failing to report debt owed by the campaign.

#### ARM 44.11.502 states:

### EXPENDITURES, REPORTING

- (1) A campaign expense paid personally by an individual in his or her own campaign is always coordinated with, and is a campaign expense of, the campaign that must be reported and disclosed as an expense by the campaign in the same manner as an expense paid through the campaign depository account.
- (2) An obligation to pay for a campaign expenditure is incurred on the date the obligation is made, and shall be reported as a debt of the campaign until the campaign pays the obligation by making an expenditure.
- (3) An expenditure is made on the date payment is made, or in the case of an in-kind expenditure, on the date the consideration is given.
- (4) The date of each expenditure shall be reported in the reporting period during which it is made.
- (5) Expenditures made from the petty cash fund need not be reported, except that an accounting shall be maintained pursuant to ARM 44.11.409.
- (6) All expenditures must be supported by a contemporaneous written agreement, invoice, billing statement, or similar documentation appropriate to the transaction that describes the services provided, the billing period identifying the specific dates on which services were provided, an itemized basis for the payments made, and other pertinent information.
- (7) For purposes of the disclosure requirements of 13-37-229 and 13-37-232, MCA, the "purpose" of each expenditure as reported on the commissioner's campaign finance reporting forms shall specifically describe the purpose, quantity, subject matter, as appropriate to each expenditure, and must be detailed enough to distinguish among expenditures for similar purposes. For example, two expenditures for direct mail advertisements should not both be reported as "Flyers."

#### 1. Violation ARM 44.11.501(7)

The: 6/17/15-4/28/16 c5 report (exhibit 1) lists a payment of \$12.50 to Kintia Copy & Creative that is described only as "MC stmt 8/24 - 9/21 #4666 no invoice / register receipt - Printing" this description does not comply with the standards set for in ARM.

#### 2. Violation ARM 44.11.501(7)

The: 6/17/15-4/28/16 c5 report (exhibit 1) lists a payment of \$50.00 to MDLCC of Helena, MT that is described only as "FIB stmt (April) Chk #1010 - fee walk cards" this description does not comply with the standards set forth in ARM.

## 3. Violation ARM 44.11.501(7)

The: 6/17/15-4/28/16 c5 report (exhibit 1) lists a payment of \$64.40 to USPS of Whitefish, MT that is described only as "FIB stmt (April) Chk #1008 register receipt - postage stamps fundraiser invitations" this description does not comply with the standards set forth in ARM.

### 4. Violation ARM 44.11.501(7)

The: 6/17/15-4/28/16 c5 report (exhibit 1) lists a payment of \$49.00 to USPS of Whitefish, MT that is described only as "MC stmt 7/23 - 8/23 #9275 register receipt - STAMPS" this description does not comply with the standards set forth in ARM.

### 5. <u>Violation ARM 44.11.501(7)</u>

The: 6/17/15-4/28/16 c5 report (exhibit 1) lists a payment of \$9.80 to Walgreens of Whitefish, MT that is described only as "MC stmt 1/23 - 2/21/16 #0300 register receipt - stamps" this description does not comply with the standards set forth in ARM.

### 6. Violation ARM 44.11.501(7)

The: 6/17/15-4/28/16 c5 report (exhibit 1) lists a payment of \$9.80 to Walgreens of Whitefish, MT that is described only as "MC stmt 1/23 - 2/21/16 #0150 register receipt - stamps" this description does not comply with the standards set forth in ARM.

### 7. Violation ARM 44.11.501(7)

The: 6/17/15-4/28/16 c5 report (exhibit 1) lists a payment of \$31.89 to Walgreens of Whitefish, MT that is described only as "MC stmt 8/24 - 9/21 #3733 no receipt - Stamps" this description does not comply with the standards set forth in ARM.

### 8. Violation ARM 44.11.501(2)

The: 6/23/16-10/04/16 c5 report (exhibit 2) lists various debts totaling \$1,563 to Artcraft Printers of Billings, MT, debt of \$170.00 to Rylan Boggs of Helena, MT and various debts totaling \$1,168.05 to MTS of Billings, MT.

The following c5 report covering 10/5/16-10/27/216 (exhibit 3) lists no debts and no payments on the outstanding debts from the 6/23/16-10/04/16 c5 report (exhibit 2).

The 10/28/16-11/28/16 c5 report (exhibit 4) lists debt payment of \$2,109.00 to Artcraft Printers of Billings, MT and debt payment of \$3,428.04. Both amounts are well above the amount of debt report to these 2 entities on the 6/23/16-10/04/16 c5 report and not included on the 10/5/16-10/27/216 report (exhibit 3)

The 10/28/16-11/28/16 c5 report (exhibit 4) also does not list either payment for or the outstanding debt of \$170 to Rylan Boggs of Helena, MT.

The campaign's failure to report outstanding on the 10/28/16-11/28/16 and 10/28/16-11/28/16 and failure to report the total amount of debt on the 6/23/16-10/04/16 report does not comply with the standards set forth in ARM.
