Commissioner Mangan:

I write today to allege violations of 13-35-225 by either candidate Chase Reynolds or a third party working for or with Candidate Reynolds.

On October 29th, I found the enclosed mail piece promoting Candidate Chase Reynolds. The mailer does not include the appropriate disclaimer information as required by MCA 13-35-225. This type of electioneering material is required to "clearly and conspicuously include the attribution 'paid for by' followed by the name and address of the person who made or finance the expenditure for the communication." It is also required to include "the candidate's party affiliation or include the party symbol."

Because the require attribution is not included, it is unclear who paid for this mail piece. I have also not found any disclosure of how widespread this communication is nor who is connected with it other than Candidate Reynolds whom it benefits.

Please attempt to investigate who produced this communication and failed to appropriately include a disclaimer before sending to voters in Missoula.

Complaints must be:

- **signed**
- **notarized**
- **delivered in person or by mail.**
