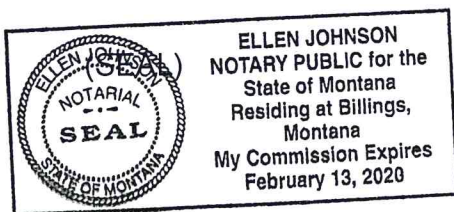

Mary Ann Dunwell, candidate for House District 84 in 2016 has violated ARM 44.11.502(7) by failing to report the purpose, subject matter and quantity of election materials.

ARM 44.11.502 states:

EXPENDITURES, REPORTING

(1) A campaign expense paid personally by an individual in his or her own campaign is always coordinated with, and is a campaign expense of, the campaign that must be reported and disclosed as an expense by the campaign in the same manner as an expense paid through the campaign depository account.

(2) An obligation to pay for a campaign expenditure is incurred on the date the obligation is made, and shall be reported as a debt of the campaign until the campaign pays the obligation by making an expenditure.

(3) An expenditure is made on the date payment is made, or in the case of an in-kind expenditure, on the date the consideration is given.

(4) The date of each expenditure shall be reported in the reporting period during which it is made.

(5) Expenditures made from the petty cash fund need not be reported, except that an accounting shall be maintained pursuant to ARM 44.11.409.

(6) All expenditures must be supported by a contemporaneous written agreement, invoice, billing statement, or similar documentation appropriate to the transaction that describes the services provided, the billing period identifying the specific dates on which services were provided, an itemized basis for the payments made, and other pertinent information.

(7) For purposes of the disclosure requirements of 13-37-229 and 13-37-232, MCA, the "purpose" of each expenditure as reported on the commissioner's campaign finance reporting forms shall specifically describe the purpose, quantity, subject matter, as appropriate to each expenditure, and must be detailed enough to distinguish among expenditures for similar purposes. For example, two expenditures for direct mail advertisements should not both be reported as "Flyers."

The: 7/01/15-4/28/16 c5 report (exhibit 1) lists a payment of \$94.69 to US Postal Service of Helena, MT that is described only as "postage for mailing" this description does not comply with the standards set for in ARM.

5. Violation ARM 44.11.501(7)

The: 6/23/16-9/29/16 c5 report (exhibit 2) lists a payment of \$133.01 to US Postal Service of Helena, MT that is described only as "postage for fundraising letters to previous donors" this description does not comply with the standards set for in ARM.

6. Violation ARM 44.11.501(7)

The: 6/23/16-9/29/16 c5 report (exhibit 2) lists a payment of \$67.40 to US Postal Service of Helena, MT that is described only as "stamps for communicating with voters" this description does not comply with the standards set for in ARM.

7. Violation ARM 44.11.501(7)

The: 6/23/16-9/29/16 c5 report (exhibit 2) lists a payment of \$34.00 to US Postal Service of Helena, MT that is described only as "postcard stamps for communicating with voters" this description does not comply with the standards set for in ARM.

8. Violation ARM 44.11.501(7)

The: 6/23/16-9/29/16 c5 report (exhibit 2) lists debt of \$657.00 to Artcraft Printers of Bozeman, MT that is described only as "GOTV mailer cards for for absentee and poll voters (not yet invoiced)" this description does not comply with the standards set for in ARM.

The: 6/23/16-9/29/16 c5 report (exhibit 2) lists debt of \$2,514.06 to Mailing Technical services of Billings, MT that is described only as "Mailing services for six card mailings (not yet invoiced)" this description does not comply with the standards set for in ARM.

10. Violation ARM 44.11.501(7)

The: 9/30/16-10/22/16 c5 report (exhibit 3) lists debt of \$627.80 to Mailing Technical services of Billings, MT that is described only as "estimated mailer expenses" this description does not comply with the standards set for in ARM.

11. Violation ARM 44.11.501(7)

The: 9/30/16-10/22/16 c5 report (exhibit 3) lists a payment of \$481.29 to US Postal Service of Helena, MT that is described only as "bulk mail and east Helena absentee" this description does not comply with the standards set for in ARM.

The: 10/23/16-11/23/16 c5 report (exhibit 4) lists a payment of \$1,137.50 to Lincini Print Shp of Great Falls, MT that is described only as "Print mailer (\$911) plus additional 500 6X11 postcards" this description does not comply with the standards set for in ARM.
