





I am filing this document in my capacity as the 2018 Campaign Manager for Lee Bridges, Democrat for HD92.
We believe our opponent, Mike Hopkins (Republican for HD92) has violated the Clean Campaign Act (Title 13, Chapter 35 Part 4 Clean Campaign Act
13-35-401) by conspiring to have a paid , scurrilous "Opinion" advertisement published on November 1, 2018 without giving the required Notice or Warning
to our Campaign. In addition, we believe that the cost of this advertisement was not reported as an in-kind donation to Mr. Hopkins' campaign.
On October 23rd, it was brought to my attention that Mr. Mike Hopkins was engaging in online chat with Mike Davis (posting under the name of Ekim Sivad
his name backwards), who claimed to have "dirt" on Ms. Bridges. Mr. Hopkins encouraged Mr. Davis to contact him personally. Subsequent Facebook
by Mr. Davis (using the name Ekim Sivad) continued to attack Ms. Bridges. These attacks were/are total falsehoods. Mr. Davis is angry with Ms. Bridges
over a matter settled in the courts in her favor and requiring his firm - D&G Crane Services - to reimburse Ms. Bridgesfor damages he caused several
years ago.
Mr. Davis informed Mr. Hopkins, on Mr. Hopkins' Facebook campaign page, that he "put in a paid advertisement in favor of you". This advertisement ran
in the weekly Seeley Lake Pathfinder in both print and online editions on November 1, 2018. This issue of the Pathfinder was the last issue before the
election. This advertisement accuses my candidate, Lee Bridges, of many things, all untrue. Since the ad was published just before the election, we were
unable to respond to the print version. We did supply a rebuttal in the electronic version, but feel the damage was already done.
Mr. Hopkins was fully aware this paid advertisement, supporting his campaign, was going to be published and did nothing to warn our campaign, or provide any sort of notice.
Furthermore, it does not appear that Mr. Hopkins' has reported the cost of this advertisement as an in-kind campaign contribution.
I have attached screen shots of the various Facebook chats and posts and the published, paid ad to support this complaint.











