Mr. Sweeney has not filed any C-7E forms for his expenditures of greater than \$100 of the 17 days leading up to the general election.

As Mr. Sweeney has filed similar complaints with this office about the same violations within other campaigns, he should very much know and understand the requirements for his own campaign filings.
