Michael J. Fasbender filed as a candidate for Lewis & Clark County Commissioner in the Spring of this year in a nonpartisan contest. He and one other candidate survived the Primary election in June, and he and the other candidate will appear on the ballot in November.

As described as **Exhibit A (1)**, an ad with a photo and explanatory verbiage was printed in the Helena Independent Record 2020 Primary Election Guide, Sunday, May 10, 2020, Page 27. Included below the photo in the ad is the statement: "Photo copyright Samantha Yearry Photography". There has been no reporting of the cost of the ad in Mr. Fasbender's reports.

No information about the cost of the photo has been included in Mr. Fasbender's campaign finance reports either. If it was paid for by Mr. Fasbender, it should be reported as an expenditure; and if it was an in-kind contribution by the photographer, it has value to his campaign and should be reported.

Again, no information about the cost of the ad itself has been included in his campaign finance reports.

Exhibits A (2) and A (3) are pages printed from Mr. Fasbender's Facebook entries from May 9 and May 13 showing the same photo and ad that appeared in the Helena I.R. as described above.

Contributions from supporters are the principal source of receipts. A contribution is defined by law, in part, as "an advance, gift, loan, conveyance, deposit, payment, or distribution of money or anything of value to support or oppose a candidate or ballot issue. . . 13-1-101(9), MCA.

In-kind contributions must be accounted for and reported in the same manner as other contributions. The in-kind item or service must be identified. The term "in-kind contribution" means the furnishing of services, property, or rights without charge or at a charge which is less than fair market value to a candidate or political committee for the purpose of supporting or opposing any candidate, ballot issue or political committee as defined . . . 44.11.702, ARM.

Exhibit B is a July 4 is a compilation of photos of the "GOP float" during the "Lincoln Montana Independence Liberty" parade.

No in-kind contribution from the Republican Party is listed on Mr. Fasbender's campaign finance reports. (See description of in-kind contributions above.)

Exhibit C (1), C (2), C (3) are photos of Mr. Fasbender's signs in various locations. The first one is a photo of various political signs in a Helena resident's front yard. This sign has a Republican Party affiliation. This is an error. The contest Mr. Fasbender is engaged in is Non-Partisan.

Distance from the camera makes it impossible to see if the same affiliation is present on C (2) and/or C (3), but, regardless, no expenditure(s) for signs are reported on any of Mr. Fasbender's campaign finance reports. Value of signs should be reported as expenditure(s).

If, on the other hand, these are re-cycled signs from his previous campaign of 2012, while he owns the signs irrespective of when purchased, all re-cycled signs still HAVE VALUE to his current campaign. This value would be expected to be reported as an in-kind contribution from Mr. Fasbenbder. I see no such reporting. He has had signs all over town and environs and several on a truck which he parks on city streets in various locations. (See description of in-kind contributions above.)

Additionally the Rodeo sign likely should be reported as well under expenditures, for the rodeo probably would require payment for use of rodeo field for advertising. (See description of expenditures above.)
