Bolger v. Montana Citizens for Right to Work No. COPP 2020-CFP-053	FINDING OF SUFFICIENT FACTS TO SUPPORT A CAMPAIGN PRACTICE ACT VIOLATION
---	--

On October 30, 2020, Trent Bolger from the Montana Democratic Party filed a campaign practices complaint against Montana Citizens for Right to Work, a registered Montana political committee. The complaint alleged that Montana Citizens for Right to Work failed to comply with the requirements of Montana's Clean Campaign Act. The complainant also requested the Commissioner examine Montana Citizens for Right to Work's classification as an Incidental political committee.

SUBSTANTIVE ISSUES ADDRESSED

Montana Clean Campaign Act and committee classification.

FINDINGS OF FACT

The foundational facts necessary for this Decision are as follows:

Finding of Fact No. 1: Montana Citizens for Right to Work (MCRTW) filed a C-2 Statement of Organization as an Incidental political committee with the COPP on May 22, 2020. Randal Pope is listed as the committee's Treasurer, with no other officers named. The C-2 does not list a purpose for the committee nor name any candidate/s or ballot issue/s supported or opposed. (Commissioner's Records.)

Finding of Fact No. 1A: MCRTW does not have an easily identifiable or publicly accessible website. MCRTW does not have appear to have any publicly accessible social media platforms or profiles.¹ (Commissioner's Records.)

Finding of Fact No. 2: Included with this Complaint was a copy of a mailer sent out by MCRTW, dated October 21, 2020, the letter states that "You see, the race for State Representative in House District 83, where you live, may be one of the most important in the state" and continues electioneering message. (Commissioner's Records.)

Finding of Fact No. 2A: Darin Gaub filed a C-1 Statement of Candidate as a Republican candidate for House District 83 in Lewis & Clark County with the COPP on February 26, 2020. (Commissioner's Records.)

Finding of Fact No. 2B: Kim Abbott filed a C-1 Statement of Candidate as a Democratic candidate for House District 83 in Lewis & Clark County with the COPP on January 30, 2020. (Commissioner's Records.)

Finding of Fact No. 3: On October 29, 2020, MCRTW filed a C-7E Notice of Pre-Election Expenditures disclosing one independent expenditure of \$7,071.98 dated October 28, 2020. The expenditure was noted as an Electioneering Communication, with Purpose provided as "Mail reporting survey results to our supporters. We do not support or oppose any candidate in this mail.", Platform as "USPS", Quantity as 15,916 and Subject Matter as "Reporting survey results to our supporters for candidates; K Regier, G Quist, C Friedel, M McDonald, J Butterbaugh, E McClafferty, S Nordwick, M Sweeney, D Solomon, C Porter Gay, L Rekston, G Browning, S Gist, J Krotkov, F Fleming, A Guiliano, J Read, L Pavlock, K Whitman, L Conley, B Tschida, L Hansen, C Owens, D Fern, E Buttry, J Horn, L Verrill-Rhys, Jessica Karjala, J Lamm, L Bishop, J Hinkle, C Campbell, D Rivera, R Farris-Olsen, D Westlake, M Funk, D Gaub, K Abbott, C Hull and M Dunwell".

On October 29, 2020, MCRTW filed a C-4 Incidental committee finance report, dated September 26, 2020 through October 26, 2020. This report included three (3) separate independent expenditures: one for \$7,287.76 dated October 21, 2020, one for \$7,615.08 dated October 14, 2020, and one for \$7,923.70 dated

October 2, 2020. Each was reported with Purpose provided as “mail reporting survey results to our supporters. We do not support or oppose any candidate in this mail.”, Platform as USPS, Quantity as 15916, and Subject Matter as “Reporting survey results to our supporters for candidates; K Regier, G Quist, C Friedel, M McDonald, J Butterbaugh, E McClafferty, S Nordwick, M Sweeney, D Solomon, C Porter Gay, L Rekston, G Browning, S Gist, J Krotkov, F Fleming, A Guiliano, J Read, L Pavlock, K Whitman, L Conley, B Tschida, L Hansen, C Owens, D Fern, E Buttrey, J Horn, L Verrill-Rhys, Jessica Karjala, J Lamm, L Bishop, J Hinkle, C Campbell, D Rivera, R Farris-Olsen, D Westlake, M Funk, D Gaub, K Abbott, C Hull and M Dunwell.” (Commissioner’s Records.)

Finding of Fact No. 3A: Keith Regier filed a C-1 Statement of Candidate as a Republican candidate for Senate District 3 in Flathead County with the COPP on October 17, 2019. Guthrie Quist filed a C-1 Statement of Candidate as a Democratic candidate for Senate District 3 on March 4, 2020.

Christopher Friedel filed a C-1 Statement of Candidate as a Republican candidate for Senate District 26 in Yellowstone County on February 14, 2020. Margaret MacDonald filed a C-1 Statement of Candidate as a Democratic candidate for Senate District 26 on July 8, 2019.

James Buterbaugh filed a C-1 Statement of Candidate as a Republican candidate for Senate District 38 in Granite County with the COPP on March 13, 2020. Edith McClafferty filed a C-1 Statement of Candidate as a Democratic candidate for Senate District 38 in Silver Bow County with the COPP on January 19, 2020.

Suzzann Nordwick filed a C-1 Statement of Candidate as a Republican candidate for Senate District 39 in Silver Bow County with the COPP on February 6, 2020. Mark Sweeney filed a C-1 Statement of Candidate as a Democratic candidate for Senate District 39 in Granite County with the COPP on July 15, 2019.

Daniel Salomon filed a C-1 Statement of Candidate as a Republican candidate for Senate District 47 in Lake County with the COPP on April 15, 2019. Chase Gay filed a C-1 Statement of Candidate as a Democratic candidate for Senate District 47 in Missoula County with the COPP on March 13, 2020.

Linda Reksten filed a C-1 Statement of Candidate as a Republican candidate for House District 12 in Lake County with the COPP on

December 4, 2019. Gerry Browning filed a C-1 Statement of Candidate as a Democratic candidate for House District 12 with the COPP on March 6, 2020.

Steve Gist filed a C-1 Statement of Candidate as a Republican candidate for House District 25 in Cascade County with the COPP on January 16, 2020. Jasmine Krotkov filed a C-1 Statement of Candidate as a Democratic candidate for House District 25 with the COPP on October 2, 2019.

Frank Fleming filed a C-1 Statement of Candidate as a Republican candidate for House District 51 in Yellowstone County with the COPP on September 27, 2019. Anne Giuliano filed a C-1 Statement of Candidate as a Democratic candidate for House District 51 on February 26, 2020.

Joseph Read filed a C-1 Statement of Candidate as a Republican candidate for House District 93 in Lake County with the COPP on January 14, 2020. Lisa Pavlock filed a C-1 Statement of Candidate as a Democratic candidate for House District 93 with the COPP on March 4, 2020.

Kathy Whitman filed a C-1 Statement of Candidate as a Republican candidate for House District 96 in Missoula County with the COPP on December 11, 2019. Loni Conley filed a C-1 Statement of Candidate as a Democratic candidate for House District 96 with the COPP on June 3, 2019.

Bradley Tschida filed a C-1 Statement of Candidate as a Republican candidate for House District 97 in Missoula County with the COPP on January 9, 2020. LouAnn Hansen filed a C-1 Statement of Candidate as a Democratic candidate for House District 97 with the COPP on November 12, 2019.

Catherine Owens filed a C-1 Statement of Candidate as a Republican candidate for House District 5 in Flathead County with the COPP on February 3, 2020. David Fern filed a C-1 Statement of Candidate as a Democratic candidate for House District 5 with the COPP on January 6, 2020.

Ed Buttrey filed a C-1 Statement of Candidate as a Republican candidate for House District 21 in Cascade County with the COPP on October 18, 2019. Jaime Horn filed a C-1 Statement of Candidate as a Democratic candidate for House District 21 with the COPP on March 16, 2020.

Leigh Verrill-Rhys filed a C-1 Statement of Candidate as a Republican candidate for House District 48 in Yellowstone County with the COPP on March 10, 2020. Jessica Karjala filed a C-1 Statement of Candidate as a Democratic candidate for House District 48 with the COPP on December 3, 2019.

Joe Lamm filed a C-1 Statement of Candidate as a Republican candidate for House District 60 in Park County with the COPP on March 12, 2020. Laurie Bishop filed a C-1 Statement of Candidate as a Democratic candidate for House District 60 with the COPP on February 19, 2020.

Jedediah Hinkle filed a C-1 Statement of Candidate as a Republican candidate for House District 67 in Gallatin County with the COPP on July 12, 2019. Colette Campbell filed a C-1 Statement of Candidate as a Democratic candidate for House District 67 with the COPP on March 4, 2020.

Dennison Rivera filed a C-1 Statement of Candidate as a Republican candidate for House District 79 in Lewis & Clark County with the COPP on March 4, 2020. Robert Farris-Olsen filed a C-1 Statement of Candidate as a Democratic candidate for House District 79 with the COPP on July 13, 2019.

Debbie Westlake filed a C-1 Statement of Candidate as a Republican candidate for House District 82 in Lewis & Clark County with the COPP on January 15, 2020. Moffie Funk filed a C-1 Statement of Candidate as a Democratic candidate for House District 82 with the COPP on September 17, 2019.

Charlie Hull filed a C-1 Statement of Candidate as a Republican candidate for House District 84 in Lewis & Clark County with the COPP on February 3, 2020. Mary Ann Dunwell filed a C-1 Statement of Candidate as a Democratic candidate for House District 84 with the COPP on July 26, 2019. (Commissioner's Records.)

Finding of Fact No. 4: On November 13, 2020, MCRTW, through Quentin Rhoades of Rhoades Seifert & Erickson PLLC, emailed the COPP its response to this complaint. The response stated that the letter included with this complaint was sent by MCRTW on October 28, 2020 and "concerned a 2020 candidate survey, which asked approximately 40 state candidates for their stance on the Right to Work, and whether they would support legislation supporting the Right to Work". MCRTW acknowledged the mailer represents an electioneering communication, but claimed it was not subject to

the provisions of Montana's fair notice period because "The mailer does not mention an "opposing candidate". The mailer does not advocate for one candidate over the other...Due to the fact the mailer does not call for the election of a particular candidate, there is no "other" candidate it could have been provided to".

Regarding MCRTW's committee classification, the response argued that "The stated purpose of the MCRW is to promote social welfare, which the MCRW attempts to accomplish by supporting Right to Work. MCRW staff are allocated to accomplishing this primary purpose. The MCRW largely comes from supporters". (Commissioner's Records.)

Finding of Fact No. 5: On February 10, 2020, MCRTW, through Mr. Rhoades, provided the COPP with copies of all materials mailed by the committee on October 28 (see Attachment A). Included with the response were copies of a "2020 Candidate Survey" conducted by MCRTW, which asked candidates four (4) questions:

Will you support efforts to enact a statutory Right to Work law in Montana?

Will you support legislation the ends monopoly bargaining over government employees by union officials?

If elected, will you oppose any legislation designed to circumvent the Supreme Court's *Janus* decision?

If elected, will you support a ban on all "project labor agreements" which, if enacted, would allow contractors to bid on state construction projects regardless of whether or not their employees pay dues to a union boss?

The letter then detailed the candidate's responses- Y for Yes, N for No. The candidates surveyed were: MacDonald and Friedel, SD 26; Quist and Regier, SD 3; Porter-Gay and Salomon, SD 47; Browning and Reksten, HD 12; Horn and Buttrey, HD 21; McClafferty and Buterbaugh, SD 38; Karjala and Verrill-Rhys, HD 48; Giuliano and Fleming, HD 51; Abbott and Gaub, HD 83; Bishop and Lamm, HD 60; Campbell and Hinkle, HD 67; Funk and Westlake, HD 82; Krotkov and Gist, HD 25.

Also included were copies of letters mailed out by MCRTW. Each letter was dated October 28, 2020, and opens by stating:

Dear Friend:

Time is running out.

Will your next State Representative allow the union bosses to keep their stranglehold on Montana workers and our state's economy, or will they stand for freedom, jobs and a better economy by working to end forced unionism in Montana?

Recipients were then specifically encouraged to contact candidates Conley, Hansen, Porter Gay, Krotkov, Campbell, Bishop, Funk, McClafferty, MacDonald, Karjala, Quist, Abbott, Browning, Horn, Farris-Olsen, Dunwell, and Sweeney², to communicate that:

But I'm afraid there's even more cause for concern.

You see, [candidate] has now begun racking up Big Labor endorsements.

It seems the union bosses would love nothing more than to send [candidate] to Helena to do their bidding.

That's why it's vital you act AT ONCE!

The letter additionally encouraged recipients contact candidates Whitman, Tschida, Salomon, Gist, Hinkle, Lamm, Westlake, Buterbaugh, Friedel, Verrill-Rhys, Regier, Gaub, Reksten, Buttrey, Rivera, Hull, and Nordwick to thank them for "pledging to fight to end forced unionism".

Also included was a self-titled "Right to Work Survey Reply Memo" meant to be returned by the recipient to MCRTW Treasurer Randy Pope. Each Memo included a section where the recipient could indicate that they had contacted candidates Quist, Browning, Horn, Krotkov, Karjala, Bishop, Campbell, Farris-Olsen, Funk, Abbott, Dunwell, Conley, Hansen, Quist, MacDonald, McClafferty, Sweeney, and Porter Gay to tell them their "refusal to disavow forced unionism is unacceptable" and demand that they renounce any support they had received from "union bosses" or that they had contacted candidates Nordwick, Reksten, Buttrey, Gist, Verrill-Rhys, Lamm, Hinkle, Rivera, Westlake, Gaub, Hull, Whitman, Tschida, Regier, Friedel, Buterbaugh, Nordwick, and

Salomon to support them for “supporting Right to Work”.
(Commissioner’s Records.)

DISCUSSION

Fair Notice Period

The first allegation made by the complainant in this matter concerns Montana’s Fair Notice period. Specifically, the complaint alleges that MCRTW failed to comply with Fair Notice requirements by not providing a copy of campaign mailers mentioning individual Montana candidates to those candidates.

Montana’s Fair Notice period and the attendant requirements are laid out under Mont. Code Ann. §13-35-402:

Fair notice period before election. (1) A candidate or a political committee shall at the time specified in subsection (3) provide to candidates listed in subsection (2) any final copy of campaign advertising in print media, in printed material, or by broadcast media that is intended for public distribution in the 10 days prior to an election day unless:

- (a) identical material was already published or broadcast; or
- (b) the material does not identify or mention the opposing candidate.

(2) The material must be provided to all other candidates who have filed for the same office and who are individually identified or mentioned in the advertising, except candidates mentioned in the context of endorsements.

(3) Final copies of material described in subsection (1) must be provided to the candidates listed in subsection (2) at the following times:

- (a) at the time the material is published or broadcast or disseminated to the public;
- (b) if the material is disseminated by direct mail, on the date of the postmark; or

(c) if the material is prepared and disseminated by hand, on the day the material is first being made available to the general public.

(4) The copy of the material that must be provided to the candidates listed in subsection (2) must be provided by electronic mail, facsimile transmission, or hand delivery, with a copy provided by direct mail if the recipient does not have available either electronic mail or facsimile transmission. If the material is for broadcast media, the copy provided must be a written transcript of the broadcast.

44.11.607, ARM adds that, for the purposes of the fair notice period, “campaign advertising” refers to reportable election activity”.

MCRTW, as part of the COPP investigation, provided the COPP the October 28, 2020 mailer that included three separate component as sent by the committee: a “2020 Candidate Survey”, with candidate responses, a “dear friend” letter, and a “Right to Work Survey Reply Memo” (FOF No. 5). The MCRTW’s mailer would not qualify as a direct endorsement of any particular candidate/s, and none *directly* call for the election of any candidate/s or the defeat of other candidate/s. The Commissioner finds the material electioneering communications under applicable Montana campaign finance law, Mont. Code Ann. §13-1-101(16). Electioneering communications qualify as reportable expenditure activity, Mont. Code Ann. §13-1-101(18)(a)(ii). No evidence would support coordination between MCRTW on any of its October 28 mailers with candidates, and the committee reported the communication as an independent expenditure on campaign finance reports filed with the COPP (FOF No. 3).

MCRTW’s response states that the material was sent out via mail on October 28, 2020, within the ten days of Montana’s November 2, 2020, general

election (FOF Nos. 4, 5). No evidence was uncovered and MCRTW does not state or argue that “identical material was already published or broadcast” (FOF Nos. 4, 5). In total, the communication directly referenced, by name, no fewer than forty (40) candidates for election in Montana (FOF No. 5).

In its response, MCRTW admitted that candidates named in the mailers were not provided with copies. They state that copies were not provided because “The mailer does not mention an “opposing candidate...Due to the fact that the mailer does not call for the election of a particular candidate, there is no “other” candidate it could have been provided to” (FOF No. 4).

Because MCRTW’s mailers do not directly call for the election of any candidate/s or the defeat of others, the committee contends that there were no “other” candidate/s to provide them to. The Commissioner examines this argument.

As a reportable electioneering communication, specifically mentioning candidates, and distributed within ten (10) days of Montana’s 2020 general election without being a re-distribution of identical materials distributed prior, the MCRTW’s October 28, 2020, mailer would satisfy the conditions of Mont. Code Ann. §13-35-402(1). Further, subsection (2) states that copies of qualifying materials “must be provided to all other candidates who have filed for the same office and who are individually identified or mentioned in the advertising”. MCRTW’s October 29, 2020, campaign finance report (C7-E) identifies, by name, no fewer than forty Montana candidates.

As the mailer was funded independently by MCRTW but did not directly support or oppose candidates, each candidate mentioned in an individual mailer would need be provided a copy. Mont. Code Ann. §13-35-402 does not provide an exemption for materials that do not directly support or oppose candidates or otherwise provide that copies of materials that do not directly support or oppose a candidate need not be provided to those candidates. Whether the material directly supports or opposes candidate/s is irrelevant to the fair notice requirements as provided by statute.

MCRTW was required to provide a copy of the material to all forty candidates mentioned in its October 28, 2020, mailer, as each was “individually identified” in qualifying advertising materials. The committee was required to provide a copy to each candidate of all material they were referenced in by name on October 28, the time each mailer was distributed to the public, Mont. Code Ann. §13-35-402(3)(b). MCRTW admitted it did not provide a copy of relevant October 28 mailer to each candidate mentioned.

MCRTW failed to meet its statutory requirements pertaining to the Fair Notice period. MCRTW failed to timely and appropriately provide copies of its October 28, 2020 campaign advertising to each candidate, a violation of Mont. Code Ann. §13-35-402.

Sufficiency Finding No. 1: There are sufficient facts to show MCRTW failed to provide candidates notice under Montana’s Clean Campaign Act on October 28, 2020 of an electioneering communications delivered within 10 days of the 2020 November 2 general election.

The Commissioner finds MCRTW failed to provide no fewer than forty candidates with a copy of the October 28, 2020, electioneering communication (as provided to the COPP by the committee as part of the investigation), a violation of Montana's Clean Campaign Act.

Committee classification

In addition to asserting MCRTW violated Montana's Fair Notice requirements, the complainant in this matter requested the "Commissioner determine if Montana Citizens for Right to Work meet the definition of an incidental committee with the organization's primary purpose as set forth in ARM 44.11.203(2)". The complaint does not otherwise mention MCRTW's committee classification.

Under 44.11.204 ARM, the COPP has the authority to consider a committee's classification status, with subsection (3) allowing for that committee status to be changed if necessary. While the COPP will be reviewing the classification of the committee as an incidental political committee, it will not be done as part of this matter.

DECISION

The Commissioner has limited discretion when making the determination as to an unlawful campaign practice. First, the Commissioner "shall investigate" any alleged violation of campaign practices law. Mont. Code Ann. § 13-37-111(2)(a). The mandate to investigate is followed by a mandate to take action; where there is "sufficient evidence" of a violation the Commissioner

must (“shall notify,” *see id.*, at § 13-37-124) initiate consideration for prosecution.

Second, having been charged to make a decision, the Commissioner must follow substantive law applicable to a particular campaign practice decision. This Commissioner, having been charged to investigate and decide, hereby determines that there is sufficient evidence to show that MCRTW violated Montana’s campaign practice laws, including, but not limited to the laws set out in the Decision. Having determined that sufficient evidence of a campaign practice violation exists, the next step is to determine whether there are circumstances or explanations that may affect prosecution of the violation and/or the amount of the fine.

The failure to fully and timely report and disclose cannot generally be excused by oversight or ignorance. Excusable neglect cannot be applied to oversight or ignorance of the law as it relates to failures to file and report. *See Matters of Vincent*, Nos. COPP-2013-CFP-006, 009 (discussing excusable neglect principles). Likewise, the Commissioner does not normally accept that failures to file or report be excused as *de minimis*. *Id.* (discussing *de minimis* principles).

Because there is a finding of violation and a determination that *de minimis* and excusable neglect theories are not applicable to the above Sufficiency Findings, a civil fine is justified. Mont. Code Ann. § 13-37-124. The Commissioner hereby issues a “sufficient evidence” Finding and Decision justifying a civil fine or civil prosecution of MCRTW. Because of the nature of

the violation this matter is referred to the County Attorney of Lewis and Clark County for his consideration as to prosecution. *Id.*, at (1). Should the County Attorney waive the right to prosecute (*id.*, at (2)) or fail to prosecute within 30 days (*id.*, at (1)) this Matter returns to this Commissioner for possible prosecution.

Most of the Matters decided by a Commissioner and referred to the County Attorney are waived back to the Commissioner for his further consideration. Assuming that the Matter is waived back, this Finding and Decision does not necessarily lead to civil prosecution as the Commissioner has discretion (“may then initiate” *see id.*) in regard to a legal action. Instead, most of the Matters decided by a Commissioner are resolved by payment of a negotiated fine. In setting that fine the Commissioner will consider matters affecting mitigation, including the cooperation in correcting the issue when the matter was raised in the Complaint.

While it is expected that a fine amount can be negotiated and paid, in the event that a fine is not negotiated and the Matter resolved, the Commissioner retains statutory authority to bring a complaint in district court against any person who intentionally or negligently violates any requirement of campaign practice law, including those of Mont. Code Ann. § 13-35-402. *See id.*, at § 13-37-128. Full due process is provided to the alleged violator because the district court will consider the matter *de novo*.
